Dear House Finance Committee,

Please prioritize the Governor's legislation to create an Alaska Energy Independence Fund in the Alaska Housing Finance Corporation.

I support HB 154 and its companion bill SB 125. It is important that these bills pass the legislature this session for a few reasons. States with established Green Banks are in a more competitive position to receive federal funding for clean energy programs under the \$27 billion Greenhouse Gas Reduction Fund administered by the Environmental Protection Agency (EPA). Funds are to be allocated by September of 2024. Since it will take time for the Alaska Housing Finance Corporation to establish the Green Bank after it is signed into law, it makes great sense for the legislature to act now. The next twelve days could determine whether we are eligible and prepared for a huge investment in clean energy and transportation projects that will save Alaskans billions of dollars in electric, home heating, gasoline, diesel, and car maintenance bills.

Federal investment tax credits for renewable energy projects were extended for a ten-year period under the Inflation Reduction Act. Another clear reason for the AK Legislature to pass a Green Bank this year is that the clock is ticking on the decade of available tax credits. These are significant, historic tax credits. With a Green Bank to provide low-interest financing and tax credits to incentivize purchases, energy efficiency construction projects, and rooftop and community solar projects will skyrocket in Alaska, providing good-paying jobs. By not moving the Green Bank bills this year, another year in the life of the IRA tax credits will be gone.

Please consider moving these bills forward this session. Good luck in the home stretch!

I am Francis Julian C. Uy, a Filipino cultural exchange teacher currently teaching in Stebbins, Alaska with the Bering Strait School District. I would like to request if possible to increase the internet speed given to schools in rural Alaska as this can be very beneficial for students and teachers.

For students, this is very beneficial as all state and national testing is done over the internet. Usually, when we have state testing, we have to limit how many students/classes can test per day since we have to share the internet between all classes for teaching and taking tests. If too many students are on curriculum websites to take lessons like Myngconnect, Zearn, fastforwad, etc. the students taking the online test have difficulty with the time allotted since the websites load longer. On the other hand, if no one uses those websites then the students are usually able to take the test a bit faster but the other students are not able to take in their lessons for that day.

For teachers, it would be very beneficial as we can attend more online training which minimizes costs of teachers travelling out to attend said training. It is also better for us to help prepare for our lessons as most of our curriculum resources are located online and need internet access to download or use in class.

Representative Edgmon and House Finance Committee,

Thank you for bringing forth and considering HB 193. Internet access in rural Alaska schools is vital to the success of our students. Currently, Dillingham City School District (DCSD) receives the BAG grant for both of our schools. This brings internet access up to 25Mbps for each school. DCSD is grateful for the BAG grant and the additional access it provides to our district, but 25 Mbps still leaves our students woefully behind in accessing educational opportunities.

In addition to educational opportunities missed because of low internet access, all state testing is on digital platforms. This means that during the four-week testing window, our schools' schedules and learning opportunities are dealt a blow in chaos. While many districts have the opportunity to have a "testing week", DCSD has to spread our testing out over the course of all four weeks of the testing window. During these four weeks, we have to put a moratorium on teachers using the internet for anything other than testing- so no informational videos, no fun supplemental educational opportunities, and no accessing learning platforms to help our students grow. We stagger testing start times so that having about 25 students log on all at once does not overwhelm our internet. This leads to students testing all day- again a disruption to the learning process and means we have students testing at non-optimal times.

It is not uncommon for teachers and students to not be able to access educational videos and supplemental educational materials. These digital resources add interest, excitement, and engagement to learning. DCSD provides access to several digital-based intervention software systems that allow students to receive the type of personalized learning that is valued and supported through best practices in education. However, can you imagine the disappointment of a student when they are working through a task/lesson on one of these platforms and the internet becomes unstable due to too many devices trying to access data at the same time? This student who has worked so hard on this task is "kicked off" and has to start over. It is frustrating at best and can be devastating to a struggling learner.

I am offering this written testimony in strong support of HB 193 Internet for Schools, in the hope that during our FY25 school year, we will be able to offer students in DCSD the opportunities they deserve to access the world and be 21st Century Learners.

Test Day Scenario


Testing day has arrived. The kids are ready. We have practiced using our Chromebooks so they are familiar with testing key functions. Some students arrive early to class so they can have a snack before we begin. My diabetic student had a low-carbohydrate breakfast to ensure stable blood sugars during testing. We are ready.

Sign in time for testing. For some reason, students are not being allowed to sign in to the testing portal. We keep getting an error. I quickly call our tech liaison who is also busy teaching their own class, but I need help. They don't know what is happening because they are getting the same error. I put in a call to the principal to see what might be going on. The internet seems unresponsive.

My principal called our Educational Technology Department to see what was going on since all testing at our school was failing. About 10 minutes later our principal made an announcement over the intercom to please stop using any personal devices during state testing time that are connected to the WiFi network. After about 30 more minutes we were able to sign in. Now my students were flustered and confused about why the test didn't start when it was supposed to. Now I have to field anxious student questions before they take their state test; Will we be late for lunch? Will I have time to finish my test? I need to go to the bathroom again!

I spoke with our tech liaison at the end of the day and found out that a cell phone in the school connected to the Visitor WiFi Network was set for automatic updates and was using all the internet. Our school only receives 25Mbps download speed. The Educational Technology Department discovered that this one cell phone was using 24.4 Mbps while updating. Just one cell phone can use our entire school's internet bandwidth.

Increasing to 100Mbps from 25Mbps is a must! Please help!!

Greetings House Finance Committee,

I am a 7-12 grade science teacher asking you to increase the school internet speed from a paltry 25 mbs to a more acceptable 100mbs. Everything teachers and students need to do requires the use of the computer and good internet speed. <u>Internet is a tool</u>, and in bush Alaska we are wielding a butter knife to hunt polar bears.

In short, I cannot do my job without good internet speed, and students can't focus and learn in the short period of time they have in school if they are constantly waiting for web pages during any online activity, research, learning game, or educational video. Below is a short bullet list of bandwidth issues I have experienced in just the last few weeks of school.

- Teachers unable to access powerschool to enter grades.
- Students cannot access internet without experience considerable lag time **every single time they use the computer.**
- As part of Brie's Law we are required to play video modules for the Child Protective Unit, but yesterday one of the classes had to cut their lesson short (to be continued today) because the internet was causing a huge lag. This is especially frustrating because the content can be a sensitive topic for many students.
- The science curriculum has labs, learning activities, interactivities, tests, short videos, text (great for students that require text to speech) and quizzes that students can only complete online.
- Other useful websites we visitBrainpop, IXL, sciencebuddies.org, Khan Academy, NewsELA (reading articles at different lexiles), YouTube (education, social emotional learning, brainbreaks) google tools such as sheets, slides, and docs, clever, etc.
- **AK STARS and MAPS testing** is implemented by the school so that half the school completes testing in one week, the other half the next week, then the third week (and throughout) students are completing make up testing.
 - What would your grade be on a two hour test if you had to wait several minutes for each question to pop up? They're frustrated and their focus is disrupted.
 Schools are evaluated based in part on these test scores. Students set goals based on MAPS scores. Bandwidth shouldn't

As a teacher, there have been manys of times that I could not access my gradebook due to bandwidth issues. As a teacher in the bush, I do not have internet at home so it is vital for me to be able to use my time at school wisely. I will have internet next year, but I should not have to use it to complete my work. I walk a little less than mile to and from school everyday in all types of weather. I should not have to use my internet to record grades. Student work belongs in the classroom, not my home.

Yesterday a group of 12 students were visiting a virtual job shadowing website and watching short video interviews with people in different career fields. First we had to access the clever website, and it took some time. Then the videos were lagging so students became unfocused and bored waiting for their content to upload and play.

Please provide us with a better educational tool.
