Analysis

This legislation makes significant changes to competency and commitment proceedings. This bill requires a court to commit someone if they are not restorable, allows a court to rely on previously conducted examinations in determining whether to commit a person for an additional 90 days if the person is not charged with a felony, and allows any restoration period to be for up to two years, regardless of the offense where a substantial probability of restoration within a reasonable period of time is found for un-convicted mentally ill people. This bill eliminates the statute of limitations for offenses that are not unclassified or class A felonies when charges are dismissed on competency grounds, and allows for the victim to be notified about civil commitment hearings when the respondent has had charges dismissed due to incompetency.

The Office of Public Advocacy will need to handle increased litigation and hearings resulting from this legislation, monitor these clients and be prepared to relitigate cases that are re-charged in the future. This will require additional staffing and expense for the Agency:

Add an Attorney 1-4 (Anchorage R: 24 S: C)

Personal Services - \$181.0 Indirect rates - \$13.7

Case costs (experts, transcripts, etc.) - \$23.1

Travel -\$4.7

Commodities - \$4.0

& Add a Public Guardian 1-2 (Anchorage R: 18 S: A)

Personal Services - \$104.2 Indirect rates - \$13.7 Commodities - \$4.0
