Dear Senators and Representatives,

As an Alaska resident, commercial fisherman, small business owner, disabled military veteran, and father; I strongly urge you to reconsider passing SB 128.

The following, SB 128 would have the legislature close the Area M salmon fisheries in June 2023. Overriding the authority of a State board will have long-lasting and unknown precedents

on future management issues, beyond Area M and beyond fisheries. This bill will cause irreparable harm to Alaska communities without any notable

beneficial impacts to Yukon/Kuskokwim chum returns.

Furthermore, the Board of Fisheries took action in February 2023 to further restrict the fishery. It is a harmful precedent for the legislature to substitute its own judgement for that of the Board of Fisheries, who has authority over state fish management. The Board is appointed by the Governor, confirmed by the legislature, and is informed by ADFG expertise, scientific data, and a very public process with hundreds of people testifying on this issue alone in February.

Despite the claims, the impact of the Area M salmon fisheries on AYK chum returns is very low according to recent scientific data.

- In February, the BOF received (2022) sampling data indicating that about 17% of the chum harvest in all of the June Area M salmon fisheries was from the coastal western Alaska stock group (meaning chum stocks from a large coastal area that spans Norton Sound to Bristol Bay).
- The harvest rate provided by scientists was 5.5% for South Alaska Peninsula and this was explicitly presented as an overestimate. This means less than 5.5% of the total chum returning to coastal western AK was harvested in Area M.
- Asian/Russian hatchery chum continue to make up the largest proportion of the Area M chum harvest in June (58%).

Despite this relatively low impact, in February 2023 the Board significantly restricted the Area M commercial sockeye fishery to try to further limit any impacts given the status of AYK chum stocks.

Specifically, the Board:

- 1. significantly reduced fishing time;
- 2. closed an entire area known for higher chum harvest;
- 3. implemented new limits/caps in the June fishery for South Unimak and the Shumagin Islands, which if reached would require ADFG to further restrict fishing in season.

The Board also approved the fleet implementing a cooperative management agreement, which requires 100% of the fleet to sign on, share all harvest data, monitor chum harvest in season in space and time, and stand down or move fishing locations when directed, to create opportunity for chum to pass through. This adaptive approach is actually the only way to ensure more passage to coastal western AK, as opposed to fixed closures in regulation that don't correspond to when chum are actually on the fishing grounds.

SB 128 will directly harm Area M fishermen, processors, and the communities dependent on these fisheries, especially Sand Point, King Cove, and False Pass. These harvests sustain families and provide the vast majority of operating revenue for these communities through local, borough, and state shared fish taxes.

- Without salmon, the multiple processors and the fishing economy they support would be

eliminated.

- 32% of the fish taxes received by Aleutians East Borough (AEB) in 2022 were from salmon
- 80% of the private sector jobs in the AEB communities are seafood-related
- the great majority of Area M salmon permits are owned and fished by Alaska residents

While the BOF did not adopt Proposal 140, the board's final regulatory action in 2023 was an improved solution to pass chum salmon through – which is the intended goal. Proposal 140, like this SB 128, would directly harm Alaska communities without any notable benefits to AYK chum returns and AYK communities reliant on chum.

Scientists are telling us that climate and ecosystem changes are having substantial impacts on salmon and salmon returns in AYK. Clear presentations from federal and state scientists point to recent marine heatwaves negatively impacting AYK chum salmon in significant, multiple ways (heat stressors, including making salmon more vulnerable to parasites, lower quality prey, and increased predators) while they are in the marine environment.

The amount of department comments, staff reports and public comments contain all the information to make an informed decision, however there is normally a tremendous amount of input. To undermine a process which is supposed to be deemed fair and made up of decision makers you vetted and confirmed would be very disappointing for all who participate in this process.

Dear Chairman Claman and Senate Judiciary Members,

I am a lifelong commercial fisherman from Petersburg, I participate in salmon fisheries in Bristol Bay and Southeast. I would like to express my strong opposition to SB 128, which would shut down Area M from June 10th to June 30th. This bill would have a devastating impact on the people and communities of the region, as well as setting a dangerous precedent for future fisheries management decisions.

The science is clear: the Area M fishery has a low impact on AYK chum. In 2022, the harvest rate for South Alaska Peninsula chum was 5.5%. This means that Area M harvested less than 5.5% of the total chum returning to coastal western Alaska. Additionally, 58% of the chum harvested in Area M were of Asian/Russian hatchery origin. This means that these fish were not even part of the AYK chum population.

The Board of Fisheries (BOF) carefully considered all of the science and data before taking action at its February 2023 meeting. The BOF rejected Proposal 140, which would have closed the Area M fishery for a fixed period of time. The BOF determined that this proposal was unlikely to meaningfully increase chum passage to the AYK region. Instead, the BOF adopted a more flexible approach that would allow for management to respond to real-time data from the field.

SB 128 would have a devastating impact on the people and communities of the Eastern Aleutians. The Area M fishery is a vital part of the local economy. It provides jobs, income, and food security for thousands of people. If the fishery is shut down, it would have a ripple effect throughout the region, devastating local businesses and communities.

In addition to the regional economic impact, SB 128 would also undermine the BOF's authority and make it more difficult to manage fisheries effectively, as well as being a bad precedent to set for future fishery management decisions. It would open the door for special

interest groups to pressure the legislature to overturn decisions that they don't like. This we	ould

What happened to the chum salmon on the Yukon River and why are Area M Commercial Fishermen Being Held Responsible?

In 2019, the Yukon River and its subsidiary rivers saw an unprecedented chum salmon die off. It was such an unpresented phenomenon, it gained international attention. Scientist linked the cause of death of these salmon to the record warm temperatures and warned because they died before they had a chance to spawn, **it would affect chum runs for years to come.** Additionally, chum that were in the ocean also died due to heat and lack of food. The life cycle of a chum is 3-6 years, which means it could be a long time until the chum stocks along the Yukon have the ability to recover. No chums returning to spawn means no chums available to harvest.

I oppose the passing of SB 128: Closing Area M during the month of June to salmon fishing. Recently, I attended the Board of Fish meetings held in Anchorage and listened to testimony from the science based community. The science reports indicated Area M fishery had a low impact on the AYK chum salmon run. At the Area M BOF meeting the Board received the most recent sampling data (from 2022) for chum caught in Area M. The harvest rate for South Alaska Peninsula chum was 5.5%. (Note: The scientists explicitly presented this as an overestimate). This means that Area M harvested less than 5.5% of the total chum returning to coastal western Alaska. The BOF also heard that 58% of the chum harvested in Area M were of Asian/Russian hatchery origin based on genetic testing. Area M.

During the BOF meetings, Proposal 140 did not pass because it was unlikely to meaningfully increase chum passage to the AYK region. Fixed time closures are ineffective because salmon migration doesn't always start and stop on a certain date, and fixed time closures do not provide management flexibility to respond to real time data from the field.

An alternative proposal was put forward to account for these factors. It closed the Section that is known for higher chum harvest. It established triggers and caps for the Shumigan Islands and South Unimak Sections, requiring the department to restrict fishing time, or close Areas if caps are met.

Further, fishing time for Purse Seine gear was reduced as follows: First fishing period in June-reduced from 88 hours to 68 hours. Second fishing period – reduced from 88 to 66 hours. Third and fourth fishing periods remain at 88 hours each, however, If 300,000 or more chum are harvested by June 18 then subsequent fishing periods in the South Unimak and Shumagin Islands will each be reduced by 44 hours (leaving 44 hours available).

If 450,000 or more chum are harvested by June 23 then the South Unimak and Shumagin Islands Sections will close for the remainder of June. The Board endorsed the seine fleet to continue implementing a cooperative management agreement. The agreement requires 100% of the fleet to sign on, share harvest data, monitor chum harvest, and stand down or to pull back from a location when directed to do so. In doing so, it will create an opportunity for chum to pass through, which was what the intent of proposal 140 aimed to do. This approach is adaptive in nature and is the only way to ensure that more chums make their way through the area.

In 2022 Area M fishermen stood down as part of the cooperative agreement in order to help reduce the chum harvest, and gave up 217 hours of the 352 allowed for fishing.

The Eastern Aleutians Area would be negatively impacted if Area M fisheries are shut down. Harm to fishermen- each being an individual small business with a family behind it. Majority of Area M salmon permits are owned and operated by Alaska residents.

Significant harm to the communities would occur. Fish taxes paid by salmon fishermen accounts for 32% of the fish taxes received by Aleutians East Borough (AEB) in 2022. 80% of the private sector jobs in the AEB communities are seafood related. Those jobs could go

away. What would fill the void by this lack of economic opportunity?

The passing of SB128 would send a negative message to all salmon fishermen in the State of Alaska.

Dear Senator Claman,

I am writing to you today for the very strong opposition of SB128. This bill is misunderstood by legislatures who do not have a grasp on the full realm of what commercial fishing entails, nonetheless, a sustainable fishery. This bill, if further movement is taken, is setting a harmful precedent for the legislature to substitute its own judgement for that of the Board of Fishers, who has authority over state fish management. This State Board is appointed by the Governor, confirmed by the legislature, and is informed by ADFG expertise, scientific data and is a very public process with hundreds of people testifying on this issue alone. Allowing further movement on SB128 would open a floodgate and invite individuals to try and manage Alaska's fisheries by legislation. Please do not allow this bill to move on from the Senate Judiciary Committee.

I was born and raised in the Interior, in the Arctic-Yukon-Kuskokwim (AYK) region, to be exact. I grew up in a community that depended on subsistence fishing, and my childhood memories are dominated by recollections of my father, my mother, and countless other members of my family and broader community going out on boats and bringing back the fish that our people had harvested and survived on for generations. I grew up fishing for subsistence, and I know how deeply important it is not only for physical survival but for the survival of the cultures and identities of Native people across Alaska.

I have lived in False Pass over the past ten years and have raised my kids there, and they too know subsistence fishery. They have created their own memories, both in False Pass and in the AYK region with my family. I have seen the harvests change in my lifetime, from years of abundance to some years where there is nothing, and I am deeply sympathetic to the impossible situation many communities in the AYK—including the one I grew up in—find themselves in with increasingly diminished salmon runs. However, I know that shutting down the fishery sometimes referred to as Area M that my community and many, many other communities in Western Alaskan depend on will not solve any of the problems the AYK is facing—it will likely simply cause more communities to suffer.

I have spent my entire life in communities deeply connected to fishery, both commercial and subsistence, and I know first-hand the importance of fishery. However, I also recognize and value the truth, and study after study has shown that the crash in AYK stocks simply cannot be attributed to the Area M fishery. We owe it to ourselves and to our children to discuss this issue with our eyes wide open to the science and the facts, not blinded by fear and blame. While the decline in AYK salmon stocks is certainly alarming, it makes no sense—not scientifically, not economically, not culturally—to shut down the Area M fishery in an effort to somehow "save" the fisheries in the AYK.

We must model respectful behavior for our children—the behavior they are currently seeing is not indicative of who we are as people, as Alaska Natives and Alaskans in general. This

infighting, this baseless blame—it is completely antithetical to the values we all hold dear and do our best to live by. This culture of Alaska Natives, which has been adopted more broadly by all of Alaska, is rooted in community, sharing, resiliency, and tenacity—because without each other, without trust and common ground and willingness to come together, no one would survive in this state we all call home.

We can do better than this. We *must* do better than this. We can fully embrace the values that have allowed our people to survive and thrive since time immemorial and stop this insidious exercise in blaming our neighbors. We all are just trying to survive and feed our families. Shutting down the Area M fishery will not bring back the AYK salmon abundance of years past—but it will inflict pain and suffering on families and communities that have nothing to do with the crisis.

I strongly encourage you to oppose SB128 and prevent it from moving forward from the Senate Judiciary Committee. I appreciate your time and consideration and for your willingness to serve the people of Alaska.

With every proposal the Board of Fisheries reviews, there is always a winner and a loser. Allowing this bill to move forward opens the door to anytime someone is unhappy with a BOF decision, they can come to the legislature to try and solve the problem. This negates the purpose the Board of Fisheries serves. They spend a lot of hard work prior, during, and after meetings reviewing hundreds of pages of comments and reports. Hello, My name is Melanie Hoblet and I am an Aleut born and raised in False Pass, Alaska. I have spent most of my life living and working in my hometown to keep our traditions, livelihoods and our community alive and well.

Our culture and identities rely heavily on our subsistence and commercial fishing way of life, which has sustained us for hundreds if not thousands of years. Our fishery is sustainable, it's longevity is living proof that we harvest salmon with conservation each and every year.

Our island is home to numerous lagoons, rivers, streams and bays that salmon spawn in and return to, any topographical map of Unimak Island shows just how many waterways we've used for generations to harvest salmon. Since regulations and new restrictions regarding levels of chums harvested during June fisheries in our area started in 1975 the number of AYK chum returns have not increased in any measurable level. And closer to the problem area, in Bristol Bay, they have harvests of 35 million fish each year for almost 10 years straight and what kind of restrictions or regulatory actions should be focused on this area. Our fishing area has a documented (McCullough 2001) 224 streams/rivers in the South Alaska Peninsula. In the last 20 years, all those escapements have been met, in order for us to have a commercial fishery. Why, if our escapements are being met in our waterways, would the Board of Fish give us openers for our area if this wasn't happening and why are other areas spreading percentage lies about bycatch. Numerous studies in the last 10 years have shown that a little over one percent of our catch is genetically similar to the fish returning to AYK. 2 oceans/seas (Pacific and Bering at approximately 60.7 million square miles combined) comprise where our salmon go to live for 4-6 years before returning to spawn. How can our area (10 to 15 thousand square miles at best) be blamed for the poor salmon returns in AYK. How can all those salmon for all parts of Alaska be just traveling through our area. None of it makes sense. Climate change, high seas trawling fisheries and asian stock decimating Alaskan stock in the wild are more plausible explanations for the poor returns for the AYK.

I strongly oppose SB128. Shutting down an entire economy for one area in Alaska will not solve the problems in another part of the State. Please post as opposing testimony.

Re: Opposition to Senate Bill 128

The Alaska constitution enshrined two fundamental principles regarding the state's natural resources – common (public) use and sustained yield. Furthermore, ADF&G was created and is overseen by a commissioner whose constitutional directives are included in statute as such: manage, protect, maintain, improve, and extend the fish, game, and aquatic plant resources of the state in the interest of the economy and general well being of the state. The Legislature created the Alaska Board of Fish in 1975 with the responsibility for conservation and development of fishery resources. For nearly fifty years ADF&G and the Board of Fish have done an admirable job, in fact, they are world renowned and often referred to as the 'gold standard' in the world for sustainable fisheries management. Turning a proven system upside down is a Pandora's box and I believe a legislative nightmare. There has never been a board of fish meeting where some group isn't unhappy with the outcome.

That aside, I would like to briefly describe the science that was considered by the board of fish members in their deliberations at the February 2023 Alaska Peninsula board meeting. Keep in mind that at the board meeting there were two days of scientific presentations and discussion with another 3 days of testimony.

This significant body of scientific knowledge included discussion of the CWAK genetic stock group which is defined as all the chum stocks from Bristol Bay, Kuskokwim, Lower Yukon, and Norton Sound systems. The information presented was derived from studies conducted by ADF&G, NOAA fisheries, and International Year of the Salmon consisting of U.S., Canada, Japan, Korea, and Russia scientists.

These studies and detailed presentations connected environmental evidence for the decline of AYK chums at various life stages. I would summarize it as follows: the research shows that adult chum returning in 2020 and 2021 were juveniles during the exceedingly warm ocean years from 2016-2019. Juvenile chum sampled in the Bering Sea during this period were in poor condition due to low prey availability and poor prey quality. Compounding this further, AYK chum then migrated during their first winter to the Pacific Gulf where they met similar poor rearing and feed conditions. These are not anecdotes; rather NOAA scientists tracked these fish over an extensive ocean grid system, measuring fat content, stomach contents (prey), determining fish health condition for one-, two-, and three-ocean year chum, while also taking tissue samples to determine genetic stock identification.

An article published on the NOAA website in August 2022 details what they discovered during these years of research: "Our science indicates that several factors working in combination due to warm water temperatures likely contributed to poor Yukon and Kuskokwim returns in the past two years."

Similarly the board of fish concluded that the scientific literature simply does not support the hypothesis that interception of AYK chum in the Alaska Peninsula (Area M) is the primary cause for AYK chum declines. Nevertheless, the board took several significant actions – they cut fishing time in June by 44 hours or about 24% during the first and second fishing periods, they increased the closed period from 32

hours to 76 hours, 2.4 times what it was in previous years, the board closed Sanak Island to fishing for all of June, and they created triggers for closing the June fishery based on evaluation of the chum harvest.

What the communities of the AYK region are experiencing due to poor chum and chinook survival is heartbreaking for all Alaskans to witness. As Alaskans, we have an obligation to help one another and the board took proportional action, even though I disagreed. As important, we as Alaskans need to understand why these regional salmon populations are experiencing poor survival. Area M is not the reason the Lower Yukon and Kuskokwim river systems are experiencing a low productivity.

My name is Justin Wilson and I'm a commercial fisherman in area M. I'm a four generation fisherman. I grew up fishing on the boat that I now own, and someday I hope to teach my son.

Our area houses the largest locally owned/ran fishing vessels. Revenues generated from salmon predominantly fund the city of King Cove, and the Aleutians East Borough. Furthermore, the borough financially supports the local school where my three children attend and my wife works as a preschool teacher. Every year I employ 5-8 local, Alaskan natives. This is not just a job to us. Fishing salmon is a part of culture and a strong part of our indigenous identity.

I spent 5 days listening and providing testimony at the board of fish meetings. Scientific evidence and testimony was provided that indicated multiple reasons for other areas to have declining chum populations and area M intercept catch was not listed as a factor.

Area M seine fishermen voluntarily stood down and did not fish several openers last year to show our solidarity and empathy to areas with declining salmon stocks, but we cannot be made the scapegoat for the entire state. We too have experienced bad salmon returns in past years with very low escapement.

However, if you study a map and look at area m in relation to the areas that is experiencing low chum returns. There is an area between that experienced record breaking years, and they are too a mixed stock fishery.

Please oppose bill SB-128. Closing the month of June for commercial salmon fishing will negatively impact native villages in areas m, potentially bankrupting our communities, and closing our remaining village schools. Thank you for your attention to this important matter. I look forward to your response and your continued support for sustainable fisheries management in Alaska.

Recent scientific data reveals that the impact of the Area M salmon fisheries on AYK chum returns is very low. Sampling data provided by ADFG indicates that only about 17% of the chum harvested in the June Area M salmon fishery were chums from coastal western Alaska. My name is Jody Cook. I own and operate a Bristol Bay Drift Gillnet vessel. I have been fishing in Bristol Bay for over 40 years.

SB 128 would cause less sockeye that are returning to Bristol Bay to be intercepted in area M. That could mean more money for me. But, I am still apposed to this Bill.

Firstly,..In my opinion this undermines the Board of Fish process that has been successfully managing the Alaska State commercial, sport and subsistence fisheries for many years. I have been involved in the State Board of Fish process and also in the Federal North Pacific Fisheries Management Council process. I have benefited from the process and I have also been economically harmed by the process. I have witnessed many times how the stakeholder testimonies and the scientific data has been weighed to arrive at a reasonable conclusion. Usually both sides of a contentious issue are not completely happy. I have seen a 48 hour transfer stand down period waived one year and reinstated the next year as the local Dillingham fleet protested. So, the process has been working and has a history of being connected to the communities at an intimate level through many years of testimony and many years of service from community and stakeholder members.

Secondly, There is a long precedent to protect local communities and insure that each community retains their historical seat at the table. That is, their historical portion of fish. The Board looked at the research and data and there was little impact from area M on AYK Chums. And in 2022, there were measures taken with stand downs from fishing that showed good faith efforts to save chum salmon . But,. even with these facts, the board listened to testimony from AYK district and the obvious shortage of chums, and was compelled to restrict the area M fishers more.

I'm not sure who was the main driver behind this Senate Bill. Hopefully it wasn't just attorneys and politicians trying to stir the pot and line their pockets at the expense of a native corporation. Hopefully this is the communities from AYK desperately looking for solutions to bring their salmon back. If so, I understand their passion, but I feel it is misguided. As fishermen we need to work together as much as possible to solve our differences. The same with communities through out Alaska. We need to be sure that we are focused on our real problem before we take drastic measures that would be devastating to other communities. Warming ocean temperatures is most likely the problem for the AYK chum and chum throughout Alaska. And choking the communities of Sand Point, King Cove, False Pass, and Akutan will not bring the chums back.

SB 128 is just a way around what has already been analyzed by those who understand all angles and all stakeholders. No body walked away from the Board meetings rejoicing. Good afternoon Chair Claman and Members of the Board.

My name is Madison Thompson. I am a member of the Unga Tribe from Sand Point, I am also a small business owner in Sand Point and a 4th generation commercial fisherman.

If passed, SB 128 would likely decimate the remaining Unangan population in the Eastern Aleutians. Our people are resilient, we have fished and traveled the waters of Area M for the last 10,000 years. But this bill would have detrimental effects on us. 80% of private sector jobs in our area are seafood-related, and most of Area M's permits are held by locals. We would be losing the largest portion of harvesting opportunity for the season, all fishermen and community residents would suffer if we lost our June season.

We sat in meetings for over 80 hours in February defending ourselves and our livelihoods with sound science and evidence. The Board of Fisheries took all perspectives into account, they are the state's expert in the field of fisheries. The recent decision by the Board is one considering all sides of the issue, and aims to further limit any impacts Area M may have on Coastal-Western AK chums. Though science has told us **the impact is already minimal.**

If passed, SB 128 would cause immeasurable harm to the people of the communities in Area M. Residents would be forced to leave their home-towns and local businesses such as ours would have to close their doors. It is wrong to pass this bill and disrespect the public process that is the Board of Fisheries meetings. Overriding board action after members of our communities flew to Anchorage to testify is unfair, and sets an unjust precedent against Area M, residents of the Eastern Aleutians, and the State Board of Fisheries forever.

My name is Frank Kelty, a former 50 year resident of Unalaska, Alaska, a former Mayor of the community for many years, I have also worked in the Alaska Seafood industry for 35 years mostly in Unalaska. I am also a member of UFA, but I am testifying on behalf of myself today. Senate Bill 128 is a terrible piece of legislation, I would urge the Judiciary committee to oppose this bill, or at least hold it in committee. This bill reminds me of the Federal Judge in Texas deciding he knew better than the Doctors and Scientists at FDA, to approve or disapprove medicine for the residents of this country that Judge is not a Doctor or Scientist. Senator Olson I've known him for many years, an I consider him a friend, he is a great politician, a fine doctor, a pilot, and a great family man. But as far as I know he isn't a fishery biologist. I think the work of the fisheries management should be left experts at ADFG, and Commissioner Vincent Lange who has been with the department for over 30 years, his knowledge, and that that of his staff are the experts, they need to make the call on fisheries management, with oversite and approval by the Board of Fisheries members who are selected by the Governor and confirmed by the legislature. This system as worked well for Alaska since statehood, once again ADFG management and the Board of Fisheries need to make the decisions on fisheries management for Alaska not the politicians in the legislature. I attended via zoom in February the Area M Board of Fisheries meeting, I listen to the heart felt testimony from the people of the AYK region and the suffering they are going through over the lack of salmon returns to there river systems. I wish it was something we could do to fix this immediately but we can't; we all know that ecosystem changes, water temperatures, ocean conditions and bycatch are all apart of the problem. Dear Honorable Senators Olson, Kawasaki and Claman:

I respectfully join the multitude of Alaskan voices that have voiced opposition to SB 128: "An Act temporarily closing the commercial salmon fishery in a portion of the Alaska 2 Peninsula and Aleutian Islands," in Area M in southwest Alaska of the Alaska Peninsula and Aleutian Islands Management Area of the State of Alaska Department of Fish and Game. These remarks are submitted in advance of the Senate Judiciary Committee hearing on SB 128 at 1:30pm today, April 21, 2023.

I am a former Executive Director the Aleutian Pribilof Islands Association, the tribal governing body for the thirteen tribes in the Aleutian and Pribilof Islands, and a former manager of the two largest municipal governments in the Bristol Bay region, the Bristol Bay Borough and the City of Dillingham (interim), the heart of the \$2 billion+ annually world's largest red salmon commercial fishery in the world. My comments here are my own.

Based on this experience, I am familiar with commercial and subsistence fishing in southwest Alaska. SB 128 was first introduced in the Alaska Legislature less than two weeks ago on April 12, 2023. SB 128 would abruptly change the historical yearly commercial fishing season practice and plans for hundreds of commercial fishermen in this area. This last minute cancellation would unfairly deprive them of the means to earn the income they need to pay their boat mortgages, putting ownership of their boats at risk, and the other fixed expenses they have already incurred in the fair expectation of this year's normal fishing season.

It would also unfairly deprive these hardworking fishermen of the income needed to pay their home mortgages and other home expenses, putting their homes at risk, as well as harming their ability to feed and clothe their families.

As the Mayor of Sand Point, Alaska, the Honorable James Smith, and others have eloquently stated, no one put at risk or harm in southwest

Alaska by SB 128 is indifferent to, or unfamiliar with, the subsistence problems of our fellow Alaskans in western and northern Alaska. However, this piece of legislation is too ill-timed and too rushed to productively resolve the problems this year that it seeks to address and will do more harm than good.

Dear Chairman Claman and Senate Judiciary Members,

My name is Karen Severson and I am representing FV Odin Inc. Our son Aaron Severson has skippered our Fishing Vessel Jodi Marie in the Area M Fishery since 2018. He left his family in Southeast for new opportunities far away from home. He has observed and excelled in this unique fishing area, its people and cultures.

We sympathize with subsistence communities affected by the drastic declines in Chinook and Chum salmon returns in recent years to the Yukon and Kuskokwim rivers.

Science shows Area M fishery has low impact on AYK chum. At the February BOF meeting the Board received the most recent sampling data (from 2022) for chum caught in Area M. The harvest rate for South Alaska Peninsula chum was 5.5%. ADF&G scientists explicitly presented this as an overestimate. This mean that Area M harvested was less than 5.5% of the total chum returning to coastal western Alaska. The Board also heard from scientists that 58% of the chum harvested in Area M were of Asian/Russian hatchery origin based on genetic testing.

The action BOF took at its February 2023 meeting was carefully crafted to be effective. The Board endorsed the seine fleet to continue implementing a cooperative management agreement. This agreement requires 100% of the fleet to sign on, share harvest data, monitor chum harvest and stand down or to pull back from a location when directed to do so.

This approach is adaptive in nature and is the only way to ensure that more chum make their way through the area. In 2022 Area M fishermen stood down as part of the cooperative agreement in order to help reduce the chum harvest, and gave up 217 hours of the 352 allowed for fishing.

The plan already set in place by BOF will reduce Purse Seine gear from 88 hours to 68 hours, resulting in 22.7% less fishing time. The second fishing period will reduce fishing time from 88 hours to 66 hours; 25% less fishing time. There will be a 76 hour closure between the 1st and 2nd fishing periods, which is a 2.4 times longer closure. The fleet has agreed to close the Sanak Island Section for Unimak District to all gear types. The Board implemented new caps in the June fishery for South Unimak and Shumagin Islands that if reached requires ADF&G to further restrict fishing in season. All this was the hard work of BOF and ADF&G working together to find compromise to a complex issue.

If the legislature starts overriding BOF decisions, we begin to wander into managing fisheries by emotion and opinion rather than based on science and facts.

Overriding a BOF decision opens the door to further intrusion by special interest groups. If the legislature involves itself in this decision, it opens pandora's box. How will they choose which decisions they choose to get involved in?

It is already difficult to get people to serve on the BOF due to the contentious issues, and the large commitment of time away from family and jobs. If the legislature starts to override decisions, it will be difficult to get people to want to serve.

The Alaska Board of Fisheries was created in 1959 for good reason, and the Legislature should let the BOF make these decisions based on science, compromise and good faith management of our State's resources.

There are other larger, explanations as to why the AYK salmon returns are low. Science is telling us that climate and ecosystem changes are having a significant impact. Presentations from federal and state scientists point to the recent marine heat waves negatively impacting AYK chum in multiple ways while they are in the marine environment.

The Eastern Aleutians Area will be negatively impacted if the Area M June fishery is closed. The communities and fishermen in this region who rely on the 32% fish tax and who employ 80% of the private sector jobs cannot afford the loss that would be created by the action of SB128.

We urge you to reject SB128 and the interference of the Alaska Board of Fisheries, its members and the public dedicated to the process.

Mr. Chair and members of the committee,

My name is Cherilyn Lundgren and I live in Sand Point. I am a member of the Qagan Tayagungin Tribe. I am employed with Aleutians East Borough School District in the Business Office. I have worked for the district for 17 plus years. I am a daughter of a retired Area M fisherman, wife of an Area M fisherman and have children that fish Area M. My Aleut family has fished many generations.

I oppose SB 128

Where is the evidence justifying closing our June Season?

Is it because others are pointing fingers at Area M?

South Alaska Peninsula region (Area M) has been taking it from all sides. Stop SB 128 today to future restrict our fisheries which would affect the communities of Aleutians East Borough. More research and studies need to be done to get to the real cause. Decisions cannot be made by accusations; they need to be made with facts and consideration of the environment effects happening around us.

Aleutians East Borough is home to over 3000 year-round residents, many with a heritage in the Eastern Aleutians that goes back hundreds of years. Our population has always been dependent on Both Subsistence and Commercial fishing. We have no other industry that sustains our communities. Without fishing, we cannot maintain our cities and local jobs. This will have an immeasurable impact on our families and school. The School District employes local teachers and teachers' aides, who know and care for our children. We may need to cut those jobs because of the loss in enrollment and revenue. Out of 26 teachers we have in the district, 6 have returned to teach in the district that they graduated from, and we have a few that have moved into the community and earned their degree.

Aleutians East Borough School District started with 6 schools and since I started working in 2005, 2 of the schools have been closed due to enrollment. Currently we have 1 of the 4 that is under the State enrollment requirement and Aleutians East Borough has been supporting the school to keep the doors open. Enrollment for Aleutians East Borough School Districts largest school has fallen to under 100 students and this has impacted our state funding. Fortunately, the Borough has helped with funding to keep these schools in operation when they have dropped under the student count required for State funding. In 2022 the AEB fish tax on salmon made up 28% of all AEB fish tax. Without the revenue from the fish taxes the Borough would not be able to help the schools stay open, causing our students and their families to relocate out of the Borough.

Dear Chairman Claman and Members of the Senate Judiciary Committee,

My name is Tom Wooding, and I am a 40-year Area M driftnet permit holder who has been working with the Board of Fisheries for 30 years. I am writing to express my deep concern regarding Senate Bill 128, which would close area M in June. As someone who has dedicated much of my life to the commercial fishing industry, I believe that this bill would be financially devastating for many fishermen in the region.

SB 128 would close the North Peninsula, which catches statistically zero CWAK chums. This decision would not only be unfair, but it would also negatively impact the livelihoods of many hardworking fishermen who depend on these waters to make a living. As the Vice President of Concerned Area M Fishermen (CAMF), I can tell you that our organization represents 80% of the commercial drift fleet in the area.

I firmly believe that the Board of Fisheries should be the mechanism for changing fisheries, not the state legislature. The Board has the expertise and knowledge needed to make informed decisions regarding fishing regulations, and their decisions should be respected. As someone who has worked closely with the Board for many years, I can attest to their dedication and commitment to protecting the fishing industry and the communities that rely on it.

Therefore, I urge you to reject Senate Bill 128. Instead, I ask that you respect the decisions of the Board of Fisheries. I've attached four figures to help explain the complex nature of the issue.

Figure 1: The first Figure shows a map of Area M, with the North Peninsula highlighted in red and the current South Peninsula June fishery in green. The yellow area shows a region that was closed by the Board of Fisheries in 2023 to reduce chum harvest. If Senate Bill 128 was adopted, it would close the entire Area M in June. Closing the North Peninsula could be very detrimental to the health of the North Peninsula sockeye systems and reduce the catch to the fleet in excess of one million sockeye.

Figure 2: The second Figure displays a graph with harvest rates for the Upper Yukon (Fall) Chum stock in red and CWAK (Summer) Chum in blue. The Bristol Bay region has a much larger harvest rate on Summer Chum than Area M. 
Figure 3: The third Figure shows the small stock composition of Upper Yukon (Fall) chum in the South Peninsula fisheries. The chart highlights the size of each stock, with different colors representing different regions. The South Peninsula fisheries have a low composition of Upper Yukon chums, compared to the other regions.


Figure 4: The fourth Figure shows a graph depicting the dramatic increase of Asian chums and the decrease in CWAK (Summer) chums in the South Peninsula fisheries. The graph shows recent changes in stock composition compared to the WASSIP report.





Dear Senator Claman and Committee members:

Concerned Area M Fishermen (CAMF) represents salmon drift net permit holders who fish the Alaska Peninsula. About 80% of the active permit holders in the fishery are CAMF members, and half of those are Alaska residents living primarily on the Kenai Peninsula, as well as King Cove and Sand Point on the Alaska Peninsula. CAMF strongly opposes SB 128.

CAMF believes the Alaska Board of Fisheries (BOF), not the Alaska State Legislature, is the proper forum for adjudicating regulatory and allocation issues within Alaskan fisheries. In the February 2023 Board of Fisheries meeting for the Alaska Peninsula, the Board listened to a full day of ADF&G staff reports on proposals before the Board, as well as 300 public testimonies over the course of an additional 3 days. In addition, there was another two days devoted to additional committee meetings where the public could offer information not covered in previous public testimony. There is simply no way for the legislature to fairly substitute its judgment for the BOF because it will have nothing resembling the full suite of ADF&G information and public input the Board did.

CAMF understands SB 128 is a result of the recent February Area M meeting and the failure of the Board to adopt proposal #140 which proposed severe restrictions in the June False Pass fishery. However, it seems to be widely misunderstood that the Board took no action in light of recent poor chum salmon returns to western Alaska, primarily the Yukon River. This is false. The Board did take restrictive action in the fishery though not to the draconian degree that proponents of proposal #140 would have liked. Fishing time WAS restricted, area WAS closed in June, and harvest "triggers" were put in place to ensure the harvest of chums caught incidentally to the sockeye fishery was constrained.

The State of Alaska has spent literally millions of dollars studying the June False Pass fishery, including in 2022. Additional catch sampling and genetic analysis of the catches in the fishery are planned for the next several years as well at a cost of additional millions. In fact, I'd be hard pressed to name another salmon fishery in Alaska studied as much as the False Pass fishery. The Board has considered all this information at length. But if we're not going to utilize the information the millions of dollars of expenditures have gained us, why do the studies? If

stakeholders who don't like a BOF decision just go to the legislature and use political muscle to nullify it, why even have the structure of a Board of Fisheries? CAMF believes it's a road the State of Alaska should not, indeed, must not, go down

Finally, CAMF also wishes to express our dismay that this poorly considered bill closes the whole of the Alaska Peninsula salmon fishery for the month of June, not just that portion of the fishery where chum salmon are incidentally caught (i.e. the False Pass fishery). There is a significant sockeye fishery that occurs on the North Peninsula (Bering Sea side) in the last 10 days of June that would also be closed if this bill were to pass. This fishery catches NO western Alaska bound chum salmon. This would have a dramatic negative impact on the participants in the fishery for not even a minimal marginal benefit to western Alaska subsistence users, so why close it? In addition, this bill would close the Nelson Lagoon fishery in June as well, again this fishery catches NO western Alaska chum salmon. Is this an intention of the bill's author? We believe closing fisheries on the Peninsula that the bill's author probably doesn't even know about is a perfect example of why the legislature has no business in involving itself in these issues. Please don't support this bill.

In 2022, the Area M seine fleet voluntarily stood down over 200 hours of its available 352 hours of scheduled fishing time to protect migrating chum stocks, the vast majority of which are of Asian hatchery origin. My name is Zach Wooding. I have been an Area M drift gillnet fisherman for 18 years and a permit holder for 10 years and am representing myself.

If senate bill 128 were to pass, it would be devastating for the fishing community in Area M. This is a misguided attempt to ignore the hard work of the Board of Fish and many community members that attended the meeting in February.

The board heard almost 300 public comments, results from multiple studies from ADF&G and NOAA, and from the biologists that manage the Alaskan Peninsula. The board built relationships and had conversations with the people of AYK and the Alaska Peninsula and carefully considered the outcomes of their actions. The Board of Fish made an informed decision to reduce the time and area of the South Unimak fishery to prevent the catch of Chum salmon. This bill would disregard those changes as well as impose unnecessary closures of the North Alaska Peninsula June sockeye fishery that does not catch any Coastal Western Alaska Chum salmon according to expansive genetic research done in the area.

We've always described our fishery as a marathon, not a sprint. AREA M COMMERCIAL FISHING FOR SALMON HAS BEEN IN EXISTANCE OR OVER 100 YEARS!!! COMMERCIAL FISHING DID NOT EXIST EXCEPT FOR SOME KING SALMON IN AYK UNTIL THE 1970'S AND WAS INTRODUCED BY SENATOR JOHN SACKETT. AYK WAS SUBSISTANCE, AND IT WORKED JUST FINE UNTIL COMMERCIAL FISHING & ROE STRIPPING STARTED.

THE ABOF DID NOT ADOPT PROPOSAL 140 WHICH ASKED TO SHUT DOWN AREA M FISHING DURING SPECIFIC TIMES DURING THE SEASON IN HOPES TO GET MORE CHUM SALMON UP TO AYK. THIS WOULD NOT HAVE BEEN AFFECTIVE BECAUSE MIGRATION OF CHUM SALMON CANNOT BE NAILED DOWN TO A SPECIFIC TIME. SAMPLING DATA PROVIDED FROM ADFG TO THE ABOF IN 2022 INDICATED ABOOUT 17% OF THE CHUM HARVEST IN THE JUNE AREA M SALMON FISHERY WERE CHUMS FROM COASTAL WESTERN ALASKA. COASTAL WESTERN ALASKA IS CONSIDERED THE LARGE COASTAL AREA THAT SPAN FROM NORTON SOUND TO BRISTOL BAY. My name is Jared Danielson, I come from a long line of fishermen in Area M. For us, fishing is not just a family tradition but a way of life. Unfortunately, recent events have threatened the future of our fishing industry, and I strongly disagree with Senate Bill 128. I firmly believe that the Alaska Board of Fisheries (BOF) should regulate fisheries instead of the state legislature.

The state of Alaska has invested millions of dollars in studying the June False Pass fishery, including the 9-year, \$9 million WASSIP study. This study is one of the most recognized and referred to for the difficult decisions made in prior board meetings. I don't believe there is another fishery in the state that has had more time and money invested into studying genetics than Area M. Moreover, a new genetic study funded by the state in 2022 once again found that Area M still does not significantly impact AYK chum salmon populations, reaffirming the consistency of science and WASSIP for that matter. Additional catch sampling and genetic analysis of catches in the fishery are planned over the next few years as well.

It's essential to have a thorough understanding of the situation before implementing drastic measures like closing a fishery. Puzzling thing, Senate Bill 128 would close the North Peninsula and Nelson Lagoon fishery in June, even though these fisheries catch no Western Alaska bound chum salmon. This would occur without any benefit to Western Alaska subsistence users.

While some people are unhappy with the BOF's decision not to adopt proposal #140, it's important to note that the Board took significant action to restrict the fishery. They implemented fishing time restrictions, closed areas in June, and established harvest "triggers" to limit the catch of chum salmon.

Although it's concerning that Western and Interior Alaska have experienced detrimental collapses in chum salmon returns, Senate Bill 128 is not the answer. The closure of Area M would have severe negative impacts as it's a vital source of income for many people in Alaska. A sudden closure could lead to job losses and economic hardship for local communities, and it will also have a ripple effect on the entire seafood industry and the economy of Alaska. This would endanger thousands of jobs in rural Alaska.

In conclusion, Senate Bill No. 128 is not a solution, but rather a knee-jerk reaction that fails to consider the complex nature of the problem. The Alaska Board of Fisheries is the proper process for regulatory and allocation issues within Alaskan fisheries. Allowing the state legislature to override intricate decisions made by the BOF could establish a hazardous standard. If

stakeholders can simply go to the legislature to overturn decisions, then what is the point of having the structure of the BOF? It's crucial that lawmakers trust the process of the BOF, trust science, and do not support SB 128.

Mr. Chair and member of the board-

My name is Christopher Wenzel and I am an Area M commercial fisherman. I Oppose Bill #128 and I will note a few reason why. At the Area M BOF meeting in February of this year the Alaska Board of Fish received the most recent sampling data (from 2022). The harvest rate was 5.5% for South Alaska Peninsula (Note: The scientists explicitly presented this as an overestimate). This means that Area M harvested less than 5.5% of the total chum returning to coastal western Alaska. Proposal 140 didn't pass – The proposal didn't/couldn't quarantee that its passage would increase chum passage to the AYK region. A fixed closure is not necessarily effective as fish migration doesn't always start and stop on a certain date. Fixed closures do not allow for flexibility in managing according to the on the grounds, real time data. There was action taken at the BOF, Closing the Sanak Island section, a section of the area that is known for higher chum harvest. The Alaska Board of Fish also approved the fleet implementing a cooperative management agreement for the False Pass fishery, which requires 100% of the fleet to sign on, share all harvest data, monitor chum harvest in-season in space and time, and stand down or move fishing locations when directed, to create opportunity for chum to pass through. This adaptive approach is actually the only way to ensure more passage to coastal western AK, as opposed to fixed closures in regulation that don't correspond to when chum are actually on the fishing grounds. This bill also closes the whole of the Alaska Peninsula salmon fishery for the month of June, not just that portion of the fishery where chum salmon are incidentally caught (i.e. the False Pass fishery). There is a significant sockeye fishery that occurs on the North Peninsula (Bering Sea side) in the last 10 days of June that would also be closed if this bill were to pass. This fishery catches NO western Alaska bound chum salmon. This would have a dramatic negative impact on the participants in the fishery for not even a minimal marginal benefit to western Alaska subsistence users. Additionally, it also closes Nelson Lagoon which also harvest no western Alaska chum. Why are areas that do not catch Western Alaska chum being closed in this bill if the idea behind the bill is to save chum? Please Vote No on bill#128 it's unjustified. Thank You for your service,

Honorable Senators.

Senate Bill 128 seeks to close commercial fishing along the Alaska Peninsula (Area M) for the month of June, 2023. This bill is an effort to address Chum salmon run declines of approximately 90% since 2019. The Area M fishery harvests only 3-6% of the run, however. Scientific consensus is that marine warm water conditions are responsible for the chum run declines, not fishing in Area M.

Having spent 22 years as a professional fishery biologist, I am appalled at the lack of attention and effort directed towards mitigating the causative factors for salmon declines in the Arctic/Yukon/Kuskokwim region. I have participated in numerous projects that identified and addressed limiting factors affecting salmonid stocks throughout the western USA.

In the most extreme cases, we retained and reared genetic broodstock throughout their life history (Snake River sockeye, Elwha River chinook, and Sacramento River winter chinook). In other cases, we trapped, transported, and raised salmonids in lieu of allowing mass mortality events (ESA bull trout, Sacramento fall chinook, Puget Sound coho). Such efforts made a significant difference in the recovery and legacy of the respective salmonid stocks.

The net effect of SB 128, if implemented, would only be to expand the hardships of fishing families, communities, and the State of Alaska as a whole. Affected parties should be spending time, energy, and money on AYK salmon run mitigation and restoration efforts rather than scapegoating Area M fisheries for climate-induced factors affecting said populations. More laws and regulations are a cop-out effort and failure to address the proximate causes of AYK salmon declines.

Not everyone has the opportunity or resources I have had to go to university. I strive to give back to my community in all ways that I can, as do many others, and hope you all consider giving back to us. 2023 is supposed to be my first season on my owned and operated vessel, crewed by my family who I aspire to teach how to fish, keeping our traditions and careers alive. Without an income, living subsistence is no longer an option either. Past closures have negatively impacted Aleutian families and communities without accomplishing the desired effect on the Western Alaska/AYK Chum Salmon stocks. How will this time be any different? I am sorry that the way of life in Western Alaska is being lost. Please do not take away my opportunity to hold onto my people's culture. Please weigh carefully on the consequences of your deliberations. Oppose Senate Bill 128. Thank you.

My name is Bob Murphy and I live in Kodiak and I am opposed to SB 128. I was one of many that was hoping to testify on Friday but did not get the chance because of the large number of people that wanted their voice to be heard. I worked for the Alaska Department of Fish and Game for five decades before retiring six months ago. I was an Area Management Biologist for the Division of Commercial Fisheries for over 30 years and in the same position for over 32 years and truly loved my job. I have been told I may have been the longest serving commercial fisheries Area Management Biologist in Alaska's history. I have been privileged to know or work with every person who held my very position since 1957. I feel honored to have that history with my predecessors. I can only imagine what they would think of SB 128 and the legislature getting involved in fisheries regulations.

While working for the department, all the while believing that my job and those of my coworkers was for the primary reason to protect the resources of the state, never once did I think the Alaska Legislature could do a better job implementing fishery regulations. Not once. Currently, regulations are developed by the Board of Fisheries and through the public process that exists by the dedicated men and women that have made up the Board of Fisheries over the years. Alaska is unique with this model process and other states do not have the public so involved and should. This process works.

The 350 miles of coastline on the North Alaska Peninsula, which lies within the Area M fishery, would be impacted negatively for no apparent reason other than the waters lie within the boundaries specified in the poorly constructed SB 128. Management areas that are closer than Area M to the AYK Region were not included in SB 128. The chum salmon harvest on the North Alaska Peninsula is small in numbers. In 2022, the North Alaska Peninsula harvested about 6 million pounds of sockeye salmon during the month of June, which would be included in the closure in SB 128. Millions of pounds of fish providing hundreds of fishermen and crew income for their families, countless processor employees many hours of work, two boroughs (Aleutians East and Lake and Peninsula) with tax revenue, and 20 million meals across the country. And at the same time these sockeye salmon were caught, there was 800 pounds of chum salmon caught. Yes that's 800. These chum salmon are not bound for AYK based on past genetics studies that the state has spent many millions of dollars trying to get the best available science to help answer these controversial fishery migration questions. Senate Bill 128 wants to close the North Alaska Peninsula sockeye salmon fishery for 800 lbs of locally caught chum salmon? It's obvious that the legislature getting involved in fisheries they are not familiar with and trying to make fishery regulations is not a positive step for the state or its people based on the impacts from SB 128 to a fishery that doesn't harvest AYK chum salmon.

SB 128 would be a first in the 64-year state history in having the Alaska Legislature become the regulatory authority for fisheries, not just in Area M as stated in SB 128, but across the state in the future because that is the precedence this bill starts. If you don't like the decision that the Board of Fisheries makes, then try the Alaska Legislature. It's poor policy that the Legislature should not even consider dabbling in. I cannot think of a reason the Legislature has the time or expertise to start regulating commercial, sport, or subsistence fisheries across the state and still be able to handle the necessary and important business of the state. Two months ago, over 300 people attended the Area M and Chignik Board of Fisheries meeting in Anchorage for 7 days. There were mountains of data presented to the Board of Fisheries by the Department of Fish & Game, other scientists, the public, and stakeholders. The Board of Fisheries looked at the science and facts and heard public testimony on the controversial issues and took action to reduce the chum salmon harvest in the South Peninsula June fishery. The Board of Fisheries is where fishery regulations should be developed, not within the legislature.

I encourage you to not support this bill and I am adamantly opposed to it. Thank you for your service.

My name is Steven Gould. I'm proud to be a fourth generation, Alaskan Native fisherman from King Cove, Alaska. King Cove is a special place to grow up because of its strong sense of community and cultural values. For me, it's home and the place I chose to raise and support my family. I wish to see my community's commercial fishing way of life continue to thrive in years to come, therefore I am in opposition of SB 128.

As a small gillnet owner, majority of my income comes from salmon. I keep hearing Yukon comments saying we have other species to fish for. As a small boat operator, we do not. For the winter seasons, my vessel only fished a total of 14 days in regards to the severely reduced quota. Fishing and solely relying on these short winter seasons alone are nowhere near the income I need to support my family for the year. With a reduced salmon season, I will not be able to continue our way of life in King Cove, Alaska.

We all are being affected by climate change. In 2020, we had the cod crash from the heat wave. Area M's state cod season quota used to be in the 20 to 30 million pound range; this year it was only 4 million pounds and lasted only 6 days. Area 0 in the Bering Sea is right next to us and had a 36 million pound quota. Climate change is affecting us all, therefore we should be working together and not pointing fingers to who's to blame.



Senator Claman and Members of the Judiciary Committee:

The Pacific Seafood Processors Association, representing shoreside processors across Alaska, does not support SB 128. Please do not pass SB128 out of the Judiciary Committee, especially absent a review from legal services.

The bill should not advance even if just for process concerns resulting from circumventing a management decision under the purview of a board that the legislature has explicitly tasked with the conservation and management of the state's fisheries. We disagree with BOF decisions all the time, but that does not mean a better place for those decisions is in the legislature, which lacks the days of public testimony, Advisory Committee input, development of proposals by further public input during committee of the whole, legal advice, and ADFG staff supporting the meetings throughout with science, technical, and management expertise.

Thank you for taking this issue very seriously. It will negatively affect Alaskan fishermen, communities, and processors in these very remote communities in the eastern Aleutians that are dependent on salmon fisheries, without the intended benefit to other salmon fisheries that are extremely critical to coastal western Alaska. Part of the reason the Board of Fish exists is to have science be part of the management decision, and to groundtruth whether a particular action will have the intended effect. This occurred in this case through the Board process, but science-driven management would be lost if the legislature starts inserting itself in specific fisheries management decisions as is the case in SB 128.
