FISCAL NOTE ANALYSIS

BILL NO. SB 129

**Analysis**

SB 129 seeks to designate in AS 35.40 the future bike path planned between Airport Way and Badger Road in Fairbanks, Alaska as the Matt Glover Bike Path.

DOT&PF estimates that 2 naming signs will be placed, one on each end, at an estimated cost of \$5.0 (in thousands). The Richardson Highway MP 337-362 Bicycle/Pedestrian Path project is a Federal Highway Administration (FHWA) funding project and the bike/ped path signage will be created and installed as part of that effort, per the intent language of this bill. This project is planned to be completed by the fall of 2024.

With the signage costs covered by the future project, the department submits a zero fiscal note for this naming legislation.
