BILL NO. SB 192

Analysis

This bill makes two changes to the Alaska Reads Act. First, it requires all students to take the statewide literacy screener three times per year instead of only once in the fall for a child to meet the proficiency benchmark. Second, it creates a more reasonable timeline for conversations with parents of third grade students who are struggling. The conversation on whether to let the child progress or not requires data. Moving the timeframe for the conversations with these parents from 45 days from the end of the school year to 15 days from the end of the school year allows parents and educators to take the third administration of the statewide literacy screener into consideration.

A one-time cost of \$6.0 is needed to update regulations with the Department of Law.
