Good afternoon,

My name is Alex Weddell, and I am a mother of a school aged child and a registered Alaska voter and year round citizen. I am writing in opposition of SB 173. Arming teachers is not the answer.

There are good reasons why arming teachers is opposed by school safety experts, teachers, and law enforcement. First, when a gun is in the classroom, students can get access to it. There have been multiple incidents of students and teachers finding misplaced firearms: in bathrooms, locker rooms, even sporting events. The notion of a highly trained teacher armed with a gun, able to respond as quickly as trained law enforcement is a myth. Law enforcement officers receive hundreds of hours of training but in states that have laws to arm school personnel, school staff receive much less training.

Please do not bring guns into our schools where children might accidentally gain access and cause injury. I would remind everyone of the 2022 incident in Anchorage where a child gained access to a firearm and killed himself and 3 other children (here is the news article).

Please instead support efforts to promote safe gun storage, and high risk or red flag laws. We need to protect our children, and bringing guns into the schools is not the answer. Guns should not be anywhere near schools.

Dear members of the Senate Labor and Commerce Committee,

Please do not support or pass SB 173 out of your committee. This bill would force schools to assign at least one teacher or staff person – or even a volunteer – to concealed carry a gun at school, if the person is willing to do it, receives some firearm training that the school district has to pay for, and meets some minimum physical and mental standards set by the school board.

SB 173 doesn't leave any discretion for school officials to decide that it is not a good idea for someone to carry a gun at school if they meet the minimum standards and are the only person willing to do so.

That is a terrible idea. I can tell you as a former school attorney that there is no way to write a policy under this bill that would preserve the discretion principals and other school officials need. Someone could be a great math teacher, but absent-minded or accident prone. Someone could be great with little kids but not great in situations involving conflict with a teenager or adult. Yet, if that person met the minimum standards and was the only person at the school who wanted to carry a gun, this bill would require the school to "grant" them the assignment to do that.

Teachers and school staff have their hands full teaching, maintaining order in the classroom and trying to keep kids safe on a normal day. We shouldn't expect them to take on the role of police officers.

One short training program is not enough to give someone the skills they need to make life and death decisions about shooting or not shooting in a school shooter emergency. Even the hundreds of hours of training police officers typically receive isn't always enough, as we saw to our horror during the Uvalde, Texas school shooting.

Bringing guns into school increases the possibility of people getting injured through an accidental discharge, a gun getting misplaced or stolen, or a person with a gun shooting someone by mistake.

We need to do more to keep guns out of our schools. Please focus your time and attention on laws that would help do that, like HB 164 on secure storage of guns and HB 162 on extreme risk protection orders.

Schools should be a safe place to learn. Allowing guns into schools only allows for more potential accidents to occur. Instead of burdening our underfunded schools with another meaningless course of direction, I'd suggest you support other legislation like,

HB 164 - The Alaska Child Access Prevention and 7 Secure Storage of Firearms Act. While I understand how the accident that killed my brother occurred, it could have been prevented if there had been more information or emphasis on gun storage safety.

HB 162 - Legislation to better enforce protective orders to prevent violence. A legal avenue to avoid harm that is sorely needed.

Other actions that could help would be to provide additional funding (beyond a reasonable Base Student Allocation) to do critical assessments of schools for safety and to provide funding to implement needed upgrades. Our school in Petersburg recently changed their access to their schools based on student threats to staff or other students. Given the number of guns owned in this State, you'd think there would be more focus on prevention instead of putting guns in the middle of where they're not needed.

Many Alaskan's rely on firearms for their personal safety or to help sustain their lifestyle. Passing reasonable laws that provide for the protection of others should be a priority.

Dear Members of the Senate Labor and Commerce Committee:

As a resident, mother, grandmother and voter in North Pole, Alaska for over 36 years, I am writing to strongly oppose SB 173, which would **require** Alaskan public K-12 schools to arm teachers, staff and/or volunteers. All of us want to prevent school shootings, but this is a bad bill in several ways.

1. Alaskan law already permits school administrators to allow guns on school grounds. The fact that none have done so only emphasizes that guns on school grounds are a bad idea. The teachers and staff I have spoken to are strongly opposed to this idea, and they are the most knowledgeable about the school environment.

2. Teachers, staff and volunteers are not trained law enforcement officers, and are very unlikely to respond appropriately in high stress situations, even with the training requirements included in the bill.

3. The training requirements are another unfunded mandate for our already severely underfunded school systems.

4. The bill provides immunity to participants in the program unless a high standard of gross negligence can be met. If my child or grandchild is injured by a gun-carrying teacher, staff or volunteer, I want legal recourse. In other states with similar laws guns have been misplaced and students have been able to access them. Again, the more guns in schools, the higher chance of fatal incidents.

There are two other bills under consideration, HB 164, which supports secure gun storage, and HB 162, which allows courts to issue and law enforcement officials to enforce protective orders preventing possession of firearms by individuals who are a danger to themselves or others (red flag law). These bills are much more likely to prevent school shootings than SB 173.

Please oppose SB 173 and support HB 162 and HB 164, for the sake of our children. Thank you for your consideration.

I am a 45 year resident of Alaska. My two young adult children attended Juneau public schools from preschool through HS. I served on school site councils and was a frequent parent volunteer.

I am writing in opposition to SB 173 – and to the intent stated in this bill that the concealed carry of firearms on school grounds by school staff or volunteers would augment responses by law enforcement during a crisis.

I wonder if this committee has consulted with law enforcement entities about this bill. I cannot imagine that they want to be in the position of going in to an active shooter situation, encountering armed teachers or parent volunteers, and having to manage these armed but inexperienced "pseudo-responders" while trying to stop a shooter. That's a recipe for chaos, confusion, and lethality.

No school staff member or volunteer will ever receive sufficient training to cope with an active shooter in a school. The Buckeye Firearms Foundation referred to in this bill offers three-day courses on preparedness to school staff and volunteers. Compare that with the months of preparatory training received by law enforcement personnel in Alaska, and their on-the-job experience that hones their judgement on how to rapidly assess and respond to a crisis situation. No armed teacher, staff member or volunteer will ever have this capability or judgement.

Guns in schools make children and staff less safe – increasing the potential for students or others to access guns within the building, and raising the potential for intentional shootings or lethal accidents.

If the Legislature really wants to address the issue of reducing gun violence, including reducing the number of deaths of innocent children in school shootings, there are measures that have proven successful in other states. These include laws such as those proposed in two bills currently before this Legislature: HB 164 the Alaska Child Access Prevention and Secure Storage of Firearms bill, and HB 162 which would establish emergency protective orders (sometimes called a "red flag law") for Alaska.

Finally, I note that this bill has not even been referred to the Senate Education Committee. Why is that? It seems like a major omission given their responsibility to help govern the education of children in our state and the safety of school communities.

Thank you for your consideration of my comments, and thank you for offering an opportunity for public testimony on this bill at the January 24 hearing in your Committee.
