Dear Representatives Edgmon, Foster, and Johnson:

The Department of Health received the following question from the House Finance Committee meeting on January 26, 2023, about the federal tobacco law:

Representative Hannan: Have revenue reductions to the tobacco Master Settlement Agreement due to non-compliance with the federal minimum tobacco age been accounted for?

Non-compliance with the federal minimum age for tobacco use of 21 years (T21) would not affect the amount the state receives from the Master Settlement Agreement. Instead, it could potentially impact the Substance Abuse Block Grant for the Division of Behavioral Health.

Effective January 1, 2023, the state is required to use 21 as the minimum legal age to purchase tobacco and nicotine products for federally mandated compliance checks. For these compliance checks, the state must have a retailer violation rate under 20 percent or risk losing up to 10 percent of the Substance Abuse Block Grant.

Due to the difference in state and federal law around the legal age to purchase tobacco and nicotine products, some retailers may continue to sell these products at the state legal age. This may increase the state's retailer violation rate if not addressed before the end of the 2023 reporting period.

Under Alaska law, the state is not statutorily obligated to enforce the federal minimum age requirement, but retailers should comply with the federal minimum legal age to purchase tobacco and nicotine products. The state will continue to educate retailers about the change in federal age requirements.
