FISCAL NOTE ANALYSIS

BILL NO. SB 168

Analysis

The bill adds a new section to Alaska Statute (AS) 16.05 to address wrongfully seized game meat when a court finds that the state or an agent of the state wrongfully seized game from an individual. The bill requires the Department of Fish and Game to provide monetary compensation to the individual in an amount approximately equal to the weight in pounds of the wrongfully seized game meat. The rate would be equal to the current prevailing per-pound retail price of beef sold in the area the where the game was originally taken.

The Department of Public Safety Alaska Wildlife Troopers exercise probable cause to cite and seize illegally taken game per AS 16.05.190. Since seized meat usually exceeds hundreds of pounds, it is typically documented and given away to charitable organizations to ensure the meat does not go to waste as criminal cases can take well over a year to resolve. If a court finds a defendant not guilty or otherwise dismisses the case, the department works with the defendant to make them whole with a comparable quality animal through the roadkill process or the next seized animal.

Since the bill requires the Department of Fish and Game to provide the monetary compensation, the Department of Public Safety is submitting a zero fiscal note at this time.
