FISCAL NOTE ANALYSIS

STATE OF ALASKA

BILL NO. HB309

**Analysis**

HB 309 would require the Alaska Board of Examiners in Optometry (“board”) to adopt regulations authorizing unlicensed agents of optometrists to perform routine services of optometry delegated by an optometrist. The legislation would prohibit an optometrist from delegating duties related to pain management and opioid use and addiction. Regulations would define the phrase “routine services of optometry.”

If the bill passes, the division will absorb the projected legal and printing costs for regulation change within the division's existing authority.

*Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services – fund source 1156 Rcpt Svcs (DGF). Licensing fees for each occupation are set per AS 08.01.065. The total amount of revenue collected approximately equals each occupation’s actual regulatory costs.*
