FISCAL NOTE ANALYSIS

Analysis

This legislation would expand the telehealth provisions allowed to out-of-state physicians under AS 08.02.130 to apply to members of the out-of-state physician's multidisciplinary care team so that those members can also provide telehealth services to Alaska patients under the circumstances listed in that section without obtaining an Alaska license. While the out-of-state physician is subject to disciplinary action by the State Medical Board, as current written, all members of the team would be subject to disciplinary action by the Department of Commerce, Community, and Economic Development. The bill creates new sections that provide the grounds for disciplinary sanctions against these team members and what those disciplinary sanctions can be.

If this legislation passes one full-time regular Investigator 3 will be required to take on investigations of complaints on unlicensed multidisciplinary care team members.

Personal Services:	FY2024 and beyond: \$114.3 for one PFT Investigator 3 (R18)
Travel:	FY2024 and beyond: \$10.0 training and investigative travel
Services:	FY2024 and beyond: \$25.0 for core services charges for PFT Investigator 3
Commodities:	FY2024 only: \$10.0 for one-time set up costs for PFT Investigator 3

Investigative costs are funded by General Fund (fund source 1004 Gen Fund (UGF)).
