FISCAL NOTE ANALYSIS

BILL NO. SB 257

Analysis

The impacts to the Alaska Energy Authority (AEA) under this legislation are: the creation of the Railbelt Transmission Organization (RTO) in AEA; the requirement that AEA immediately assume the integrated grid planning and capital program duties under AS 44.83.730 of the bill to later be transferred to the RTO; the requirement that AEA transfer backbone transmission assets to the RTO; and, the requirement that AEA, with the Regulatory Commission of Alaska, adopt regulations to implement the changes made by the bill related to the RTO. These additional duties will increase AEA's operational costs.

Alaska Industrial Development and Export Authority (AIDEA) provides all staff support for AEA programs and is reimbursed via a reimbursable services agreement from AEA. This fiscal note reflects the personal services costs associated with AEA's SB 257 fiscal note for these three new positions.
