FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION

Analysis

This legislation amends AS 16.05.340 to establish an angler access surcharge on sport fish licenses and AS 16.05.130 to create a sub-account within the Fish and Game Fund to collect the funds, referred to as the Sport Fishing Angler Access Account. The fees would be used to directly fund angler access projects without impact to other Division of Sport Fish programs and results in additional funds available for the division to use as match for Dingell-Johnson dollars on angler access projects.

The licensing fee structure of this legislation would take effect January 1, 2025. By using a five-year average of license sales and deducting 10% for vendor commissions and overhead, the department estimates the surcharge revenue generation at approximately \$4.1 million annually and half that amount for FY2025 at \$2.06 million.
