<u>ORDER</u>

On 6 October 2022 the Court issued the following Order:

proposals about how his request should be presented to the grand jury for its consideration.

The October hearing was relatively short and did not allow Garber sufficient time to explain his request. The Court set a continued hearing for 14 December 2022.

On 1 December 2022 the Alaska Supreme Court issued SCO 1993, a copy of which is attached. The Order amends Criminal Rule 6.1. It adds a new Rule 6.1(c) that defines how a citizen may request to have the grand jury investigate matters of public welfare or safety. The citizen must present the request "to the Attorney General for consideration and for possible review and investigation by a grand jury." There is no provision that permits a citizen to present his request to the superior court or the presiding judge.

Therefore, the hearing set for 14 December 2022 is VACATED.

Garber may present his request to the Attorney General.
