The majority of victims in shootings by police—84 percent overall—were reported as armed with a firearm or other weapon, such as a knife or vehicle, during a six-year study period. In more than half of these fatal shootings—57 percent or 3356—someone other than a police officer was also armed with a firearm. Overall, 364 (3 percent) of injured people possessed a replica or BB gun and 1,531 (14 percent) were armed with a knife. In contrast, in 955 (9 percent) of shootings, the injured person was not armed. If a intimately connected family member, friend or even an 'intimate' professional contact (therapist) had been able to notify authorities of that person's emotional distress, prior to incident report and the need to call for help (as SB 229 may have enabled), especially if they be a legitimate {or even illegitimate!} gun owner, many of these victims would today still be alive, and not have martyred themselves to capital's unfettered profit seeking!
