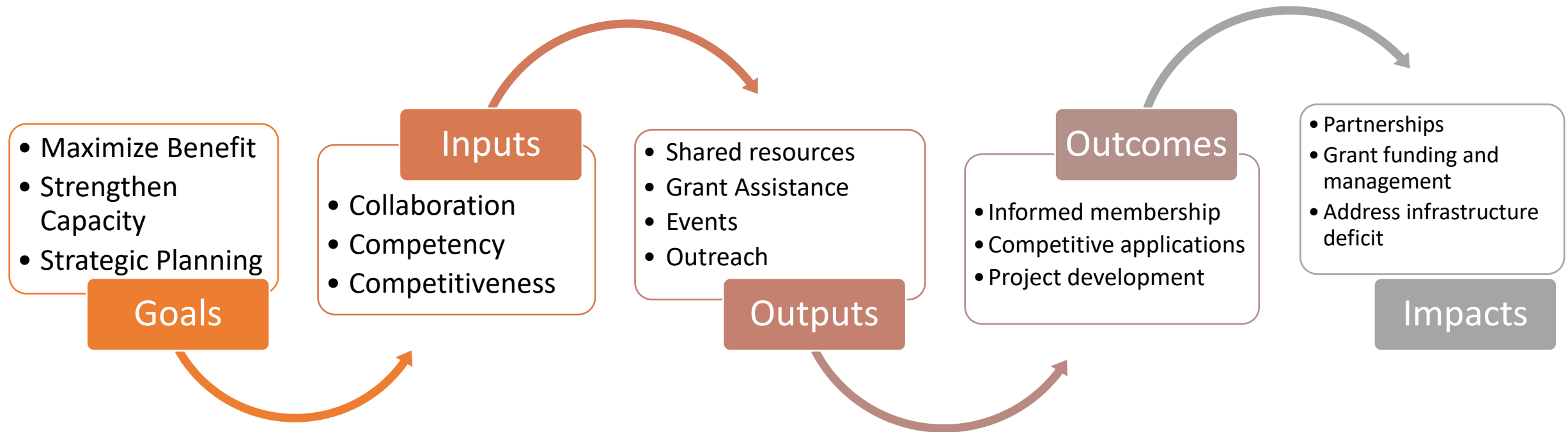

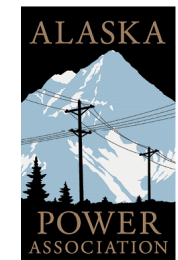

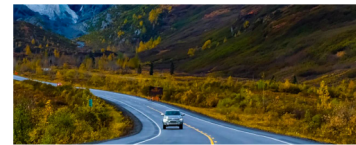
## Submit a Project

Alaska DOT&PF and Alaska Municipal League (AML) have partnered to help you pair your project with a funding program that will best suit your project goals. Once you submit a project intake survey, the information you provide will be used to match the project with opportunities your project is likely to be competitive for. If a match can be found, Alaska DOT&PF or AML will reach out to you to gather more information and help you submit a successful application. The survey is comprehensive in order to help identify the best opportunity match, any information you don't know can be determined at a later date.



## Discover State Programs

The Alaska Transportation Funding Opportunity Hub currently provides information and support for the TAP and CTP programs. From the program page you can view the program application schedule, review evaluation criteria and submit a notice of intent to apply. Not sure which to apply for, or want your project to be considered for all available opportunities? Submit a project intake survey and it will also act as the Notice of Intent to Apply (NOIA) for state programs. Alaska DOT&PF will add programs as they become available. Be sure and check back regularly.

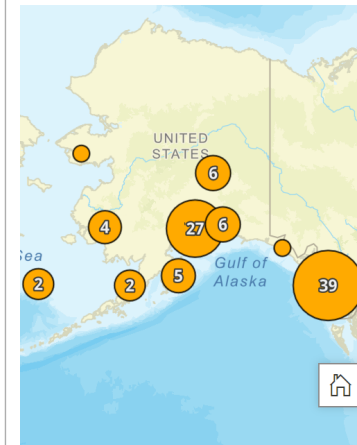


## Discover Federal Opportunities

## Takeaways

- The scale and scope of the infrastructure package is immense and overwhelming
- Urgency can be spread across at least the next five years; implementation over the next ten
- Many federal agencies are still in the midst of developing NOFOs and programs
- There are new criteria to many programs, which include equity, sustainability, new technologies, etc.
- Federal agencies have and will ramp up technical assistance
- The State of Alaska will have some role in supporting communities through this process

## Challenges and Opportunities

- Needs, Assets, and Priorities – What are barriers that you're currently dealing with, and needs in the community? Who are you working with? What priorities have you identified?
- Maintenance and Operations – What needs to be done now to improve? On the other side of this investment, what does this look like? How can we prepare?
- Procurement Planning – Are there statewide or regional approaches to procurement that could be considered? How to know and who could organize?
- Intergovernmental Collaboration – How do we encourage municipal and Tribal collaboration within communities? How do local and Tribal governments work more closely with the State?
- Match Requirements – What are match requirements that might keep you from applying for a grant? Where do you turn for help with match?
