


2022 Reform

 - Tribal relationships 1st Tribal Liaison hired






FY2017 – 2023 Progress

Sucesses

- Over 600 building inspections conducted
- Over 700 fire and building plan reviews completed
- Two new positions (FY22) are reducing plan review turnaround time by over 33%
- Investigated 45 fires involving fatalities and/or significant damage.
- Issued fire certification for 1093 applicants
- Worked with Village Public Safety Officers to improve fire safety in rural Alaska.


Challenges

- Residential fires are Alaska's largest number of structure fires
- No authority to enforce single-family residential code requirements
- Many rural fire departments require significant and essential support from the Division and lack fully qualified personnel


