FISCAL NOTE ANALYSIS

STATE OF ALASKA
2026 LEGISLATIVE SESSION**Analysis**

This bill makes criminally negligent homicide a class A felony if the person causes the death of another person while operating a motor vehicle and failed to stop and render aid as required under AS 28.35.050 and 28.35.060. Criminally negligent homicide under this provision would have an enhanced presumptive sentencing range of 7 to 11 years for a person who has not been previously convicted of a felony. Additionally, the bill requires a minimum consecutive term of imprisonment of ten years on top of the sentence received for criminally negligent homicide for each additional conviction of failing to stop and render aid as required under AS 28.35.050 and 28.35.060. Therefore, if a person were convicted of criminally negligent homicide under this bill they would be subject to a minimum presumptive term of 7 – 11 years with an additional 10 years served consecutively.

Between 1/1/2020 and today, there have been approximately 13 distinct cases referred to the Criminal Division that meet the circumstances outlined in the bill. While the enhanced sentencing provision and mandatory consecutive sentencing provision may result in some additional litigation, it is uncertain whether this additional litigation would have a fiscal impact. Therefore, the division submits a zero fiscal note at this time and will continue to monitor the impacts of this bill to determine whether additional resources may be needed in the future.
