## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2025 LEGISLATIVE SESSION**Analysis**

This bill amends the public school funding formula in AS 14.17, by increasing the secondary school vocational and technical instruction (CTE) factor from 1.015 to 1.04. The increase to the CTE factor results in a projected increase in State aid funding for Mt. Edgecumbe High School (MEHS) of \$104.0 in FY2026.

As a division of the Department of Education and Early Development, MEHS' State aid is budgeted as interagency receipts. This fiscal note increases their budgeted interagency receipt authority by the \$104.0 projected increase. The correspondence factor change under AS 14.17.410 and pupil transportation program per student amount changes under AS 14.09.010(a) do not impact MEHS.

The effective date for these provisions is July 1, 2025 (FY2026).
