FISCAL NOTE ANALYSIS

Analysis

This legislation moves marijuana licensing renewals from annually on June 30 of each year to biennially on June 30 of even numbered years and reduces the tax on marijuana to \$12.00 an ounce at the marijuana cultivation facility.

The Alcohol and Marijuana Control Office's (AMCO) annual budget for marijuana activities from program receipts is \$2,131.2 in FY2026. Annual new marijuana revenue collections in FY2024 were \$3,034.3. Revenues not expended in a fiscal year carry forward to the next year.

Moving to biennial licensing will require AMCO to adjust fees on a biennial basis to cover two years of operations. If this legislation is adopted, the fee amount per licensee is expected to increase in FY2026 to cover the biennial costs, but annualized costs per licensee are anticipated to be reduced over the biennial period because AMCO currently collects more revenue than is required for program operations. Changes to revenue shown in this fiscal note are estimated based on the budgeted amount for marijuana regulation in FY2026. Actual changes in revenue and fee changes will not be known until the fee analysis is completed in FY2026.

AMCO will complete a regulations project to set fees for FY2026, and every two years thereafter. \$5.0 is required for legal costs to review regulations and publications and printing costs for public notice requirements.
