Sec. 3. This Act takes effect on the day after its passage and approval or on the day it becomes law without such approval.

## CHAPTER 150

### AN ACT

**Relating to highways and highway financing; amending Subsec. (g) of Sec. 48-5-2, ACLA 1949 as last amended by Ch. 124, SLA 1960.**

(S.B. 183)

**Be it enacted by the Legislature of the State of Alaska:**

Section 1. Subsec. (g) of Sec. 48-5-2, ACLA 1949 as last amended by Ch. 124, SLA 1960 is amended to read as follows:

(g) The monies herein collected from the taxes on all motor fuels, except the fuels named in subsections (e) and (f) of this section, shall be covered into a special "highway fuel tax" account in the state general fund. The Legislature may appropriate therefrom funds to be expended by the Department of Public Works directly or as matched with available Federal-aid highway monies for maintenance of highways; construction of highway projects and ferries included in the program provided for in Section 3, Article IV, Title II, Chapter 152, SLA 1957, including approaches, appurtenances and related facilities and acquisition of rights-of-way or easements; and other

highway costs including surveys, administration, and related matters. It shall be the policy of all departments of the state government authorized to expend funds collected from taxes imposed by this Act, to perform whenever feasible, all construction and/or reconstruction projects by contract after such projects have been duly advertised for competitive bids except that when feasible, arrangements shall be made with political subdivisions to carry out such construction and/or reconstruction projects. Whenever it is not feasible for the work to be performed by State engineering forces, the Commissioner of Public Works may enter into contracts on a professional basis with private engineering firms for road design, bridge design, and services in connection with surveys; provided that when more than one private engineering firm is available for such work the contracts shall be entered into on a negotiated basis.

## CHAPTER 151

### AN ACT

**Appropriating \$14,948 from the Public Employees' Retirement System of Alaska to the Department of Administration for administrative costs of the system for the fiscal year ending June 30, 1961; allowing for necessary advances from the general fund; and providing for an effective date.**

(S.B. 184)

**Be it enacted by the Legislature of the State of Alaska:**

Section 1. The sum of \$14,948 is hereby appropriated from the Public Em-

ployees' Retirement System of Alaska to the Department of Administration for administrative costs of the system for the fiscal year ending June 30, 1961 according to the following schedule:

Personal Services	\$ 8,280
Travel	1,050
Contractual Services	4,678
Commodities	200
Equipment	740
Total	\$ 14,948

Sec. 2. Within the limitations of the appropriations set out in Section 1 of

this Act, amounts may be advanced from the general fund of the state for such administrative costs after July 1, 1960 and prior to the effective date of the "Public Employees' Retirement System" Act, provided that such advances shall be refunded to the general fund from the system after the effective date of the "Public Employees' Retirement System" Act.

Sec. 3. This Act shall take effect July 1, 1960.

## CHAPTER 152

### AN ACT

**Appropriating from the general fund, the highway fund and certain other special funds of the state to make the employer contributions required by the act establishing the "Public Employees' Retirement System" for the six month period beginning January 1, 1961 and ending June 30, 1961; and providing for an effective date.**

(S.B. 185)

**Be it enacted by the Legislature of the State of Alaska:**

Section 1. The following amounts are hereby appropriated from the listed funds of State of Alaska to the "Public Employees Retirement System of Alaska" for the six month period beginning January 1, 1961 and ending June 30, 1961, to cover the state's employer contributions as required by Sec. 10 of the act establishing said system:

General Fund	\$302,800
Highway Fund	22,500

Water and Harbor Facilities Fund	790
Fish and Game Fund	6,000
Social Security Administration Fund	220
Teachers' Retirement Fund	295
World War II Veterans Revolving Fund	2,215
Agricultural Revolving Loan Fund	290

Sec. 2. This Act shall take effect January 1, 1961.
