

## SENATE RESOLUTION NO. 13

**Relating to the delay in construction of the Fairbanks-Nome Highway.**

**Be it Resolved by the Senate:**

WHEREAS the Senate in 1961 did by approval of Senate Resolution No. 27 advise the then Division of Highways now the Department of Highways that it was the intent of the Legislature that one million dollars of highway construction bonds authorized by the people in 1960 be programmed for survey and construction of Route S-680, the Fairbanks-Nome Highway; and

WHEREAS the 1961 resolution further

requested that work be begun on both ends of the highway; and

WHEREAS the request is now three years old and the Department of Highways has not made any progress on the project;

BE IT RESOLVED that the Governor is respectfully and urgently requested to direct the Department of Highways to proceed without further delay to accomplish the necessary programming for and the construction of Route S-680, the Fairbanks-Nome Highway.

Passed by the Senate February 26, 1964.

## SENATE RESOLUTION NO. 14

**Relating to the building of a seawall at Kotzebue.**

**Be it Resolved by the Senate:**

WHEREAS the city of Kotzebue is located on federal land and has federal installations located there; and

WHEREAS the seawall at Kotzebue is old and almost useless, and offers little or no protection against the sea; and

WHEREAS there is danger to life and property from a storm-driven sea until the city is protected by a new seawall;

BE IT RESOLVED that the Corps of Engineers, United States Army, is respect-

fully urged to construct a seawall at Kotzebue as a protection for the lives and property of the people living there and at the federal installations; and be it

FURTHER RESOLVED that copies of this resolution be mailed to the Honorable Cyrus R. Vance, Secretary of the Army; the Honorable Pat McNamara, Chairman, Committee on Public Works; the Honorable Henry M. Jackson, Chairman, Interior and Insular Affairs Committee; Colonel Kenneth T. Sawyer, District Engineer, Corps of Engineers, U. S. Army; and the members of the Alaska delegation in Congress.

Passed by the Senate February 28, 1964.

## SENATE RESOLUTION NO. 15

**Relating to the mineral mapping of Northwestern Alaska.**

**Be it Resolved by the Senate:**

WHEREAS less than two per cent of the area of Northwestern Alaska has had the benefit of mineral mapping; and

WHEREAS mineral mapping is essential to the economic development of any region, but particularly so in Northwestern Alaska where mineral activity continues to be the most promising aspect of the local economy;

BE IT RESOLVED that the U. S. Geological Survey is requested to accelerate its program of mineral mapping in Northwestern Alaska; and be it

FURTHER RESOLVED that copies of this resolution be sent to the Honorable Stewart L. Udall, Secretary of the Interior; the Honorable Thomas B. Nolan, Director, U. S. Geological Survey; and the members of the Alaska delegation in Congress.
