10 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 WHEREAS since 1915 the community of Metlakatla has had its own magis-  
12 trate and police force with certain limited criminal jurisdiction pursuant  
13 to its constitution adopted under federal law; and

14 WHEREAS in 1958, the United States Congress passed Public Law 85-615  
15 extending state criminal jurisdiction over all the Indian territory of  
16 Alaska which had previously been under territorial law; and

17 WHEREAS the community of Metlakatla was unaware of the change in the  
18 law until years later and continued acting under its local police powers;  
19 and

20 WHEREAS Public Law 85-615, by delegating total criminal jurisdiction  
21 to the state, works a great hardship on this community because the state  
22 police have limited manpower making it impossible for them to deal effective-  
23 ly with minor criminal offenses in the somewhat isolated community of  
24 Metlakatla; and

25 WHEREAS Public Law 85-615 destroyed the effectiveness of the local  
26 police and judiciary and created a gap in law enforcement in the area; and

27 WHEREAS an amendment giving this community concurrent criminal juris-  
28 diction is not without precedent in laws dealing with the Indians in that a  
29 similar arrangement exists between the state and Indian communities in

1 Idaho and there are specific exceptions to 18 U.S.C. 1162;

2 BE IT RESOLVED that the Congress of the United States is respectfully  
3 urged to amend Public Law 85-615 to give the community of Metlakatla con-  
4 current criminal jurisdiction over minor offenses.

13 W. Pollock, U. S. Representative, members of the Alaska delegation in
