MEMORANDUM

May 21, 1968

TO: Users of the 1968 Session Laws of Alaska

FROM: The Revisor of Statutes

Under the authority of AS 01.05.031, the revisor of statutes has renumbered certain Alaska Statute sections appearing in the 1968 session laws, as indicated below, to make the material more closely conform to the arrangement of the Alaska Statutes. The new numbers become the "official" ones which will appear in the 1968 supplement to the Alaska Statutes and should be used in citing the material involved.
