MEMORANDUM

TO: Users of the 1970 Session Laws of Alaska
FROM: The Revisor of Statutes

Under the authority of AS 01.05.031, the revisor of statutes has renumbered certain Alaska Statutes sections appearing in the 1970 session laws, as indicated below, to make the material more closely conform to the arrangement of the Alaska Statutes. The new numbers become the "official" ones which will appear in the 1970 supplement to the Alaska Statutes and should be used in citing the material involved.

In chapter 65 the "Article 2" designation has been deleted.

In chapter 101, sec. 3, which lacked a number in the Alaska Statutes codification, has been designated AS 47.30.470(7).

In chapter 113, sec, 6, "Article 9. General Provisions" has been designated "Miscellaneous Provisions" and a new article heading, "Article 10. General Provisions" has been inserted above AS 42.05.701.

In chapter 148, sec. 21, the last two sentences of AS 08.64.311 have been put in a new section designated "AS 08.64.313. In-active License."

In chapter 161 the change in numbering required deletion of the "Article 5" designation.

In chapter 166 the change in numbering required changing the "Article 10A" heading to read "Chapter 33."

In chapter 213 the change in numbering required establishing a new chapter headed "Miscellaneous Provisions."

In chapter 235 the change in numbering required changing the "Article 3" heading to read "Chapter 3."
