Under the authority of AS 01.05.031, the revisor of statutes has renumbered certain Alaska Statute provisions appearing in the 1983 Session Laws to conform to the arrangement of the Alaska Statutes and to maintain a logical organization of the statutes. The numbering found in SLA chapters and the number which will appear in the Fall 1983 supplements to the Alaska Statutes are shown below. Also shown are numbers which have been changed to reflect renumbering of statutes in connection with the replacement of certain title pamphlets during 1983.
