5 \* Section 1. LEGISLATIVE PURPOSE. The purpose of this bill is to recognize the dedication and  
6 hardships endured by the members of the Alaska Territorial Guard during their service to their state and  
7 their country during World War II and to accord them the same status as other veterans in the state.

18 line of duty, between June 25, 1950, and January 31, 1955, or who served in the armed

20 because of injury or disability incurred in line of duty, between August 4, 1964, and  
21 July 1, 1977, or who served in the Alaska Territorial Guard for 90 days or more or

5 education.

6 (3) A person who is eligible for veteran's benefits under the laws of any other  
7 state or territory is not eligible for the benefits of this section unless the person has lived in the  
8 state or territory for at least five years following the end of the person's service in the Alaska  
9 Territorial Guard or release from active military service. A World War II veteran who  
10 received a bonus under former AS 26.15.120 and former AS 26.15.150 need not repay the bonus  
11 in order to qualify under the loan provisions of this section.
