The exceptions to that rule are: hospitality in another person's home or at a social event or meal, discounts available to the public, food that is native to the state, gifts of travel and hospitality to obtain information on matters of legislative concern, gifts from recipient's immediate family, gifts from foreign governments delivered to Legislative Council and gifts not connected with recipient's legislative status. A person who accepts a gift of over \$100 under the "matters of legislative concern" exception must disclose receipt of the gift.




