**A BILL**

**FOR AN ACT ENTITLED**

1 "An Act relating to the Board of Fisheries; and providing for an effective date."

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 \* **Section 1.** AS 16.05.221(a) is amended to read:

4 (a) For purposes of the conservation and development of the fishery resources  
5 of the state, there is created the Board of Fisheries composed of **three** [SEVEN]  
6 members appointed by the governor, subject to confirmation by a majority of the  
7 members of the legislature in joint session. The governor shall appoint each member  
8 on the basis of interest in public affairs, good judgment, knowledge, and ability in the  
9 field of action of the board, and with a view to providing diversity of interest and  
10 points of view in the membership. The appointed members shall be residents of the  
11 state and shall be appointed without regard to political affiliation or geographical  
12 location of residence. **The governor shall designate one member of the board as**  
13 **chair of the board. The member designated shall serve as chair for a term of two**  
14 **years, and may be designated chair for successive two-year terms. A member of**  
15 **the board may not have a vested economic interest in an interim-use permit, entry**

1 permit, commercial fishing vessel or gear, or in any fishery resource processing  
2 or marketing business. The commissioner is not a member of the Board of Fisheries,  
3 but shall be ex officio secretary.

4 \* **Sec. 2.** AS 16.05.221(c) is amended to read:

5 (c) Members of the Board of Fisheries serve staggered terms of four years  
6 and until a successor is appointed. Members of the [BOARD OF FISHERIES OR]  
7 Board of Game serve staggered terms of three years and until a successor is appointed.  
8 An appointment to fill a vacancy in the membership of the Board of Fisheries or Board  
9 of Game shall be made in the same manner as the original appointment and for the  
10 balance of the unexpired term.

11 \* **Sec. 3.** AS 16.05.290 is amended to read:

12 Sec. 16.05.290. COMPENSATION OF BOARD MEMBERS. Each member  
13 of the Board of Game [A BOARD] is entitled to compensation at a rate equal to Step  
14 A, Range 20, of the salary schedule in AS 39.27.011(a) for Juneau, Alaska, for each  
15 day going to and from and for each day in actual attendance at board meetings. For  
16 other meetings or conferences authorized by the [A] board, a member shall receive  
17 compensation at a rate equal to one-half of Step A, Range 20, of the salary schedule  
18 in AS 39.27.011(a) for Juneau, Alaska, for each day going to and from and for each  
19 day in actual attendance. Each member of the [A] board is also entitled to travel  
20 expenses and per diem authorized for boards and commissions under AS 39.20.180.

21 \* **Sec. 4.** AS 16.05.290 is amended by adding a new subsection to read:

22 (b) Members of the Board of Fisheries are in the exempt service and are  
23 entitled to a monthly salary equal to Step C, Range 26, of the salary schedule in  
24 AS 39.27.011(a) for Juneau, Alaska.

25 \* **Sec. 5.** AS 16.05.320 is amended to read:

26 Sec. 16.05.320. QUORUM. A majority of the members of a board constitutes  
27 a quorum for the transaction of business, for the performance of any duty, and for the  
28 exercise of any power. However, a majority of the full board membership is required  
29 to carry all motions, regulations, and resolutions. A majority of the members of each  
30 of the boards of fisheries and game constitute a quorum for the transaction of business  
31 in a joint board meeting. A majority of the membership of each of the boards is

1 required to carry all joint motions, regulations, and resolutions of the boards.

2 \* **Sec. 6.** AS 39.25.110(11) is amended to read:

3 (11) the officers and employees of the following boards, commissions,  
4 and authorities:

12 \* **Sec. 7.** The governor shall appoint, and submit to the legislature for confirmation by the  
13 10th legislative day of the Second Regular Session of the Nineteenth Alaska State Legislature,  
14 three persons qualified to serve on the Board of Fisheries as restructured by secs. 1 - 6 of this  
15 Act. Notwithstanding AS 16.05.221(c), as amended by sec. 2 of this Act, the governor shall  
16 appoint one person to serve on the board for an initial term of two years, one person to serve  
17 on the board for an initial term of three years, and one person to serve on the board for a term  
18 of four years.

19 \* **Sec. 8.** (a) This section of this Act does not take effect if sec. 9 of this Act is passed  
20 by concurrence of two-thirds of the membership of each house of the Alaska State Legislature  
21 as provided under art. II, sec. 18, Constitution of the State of Alaska.

22 (b) Notwithstanding secs. 1 - 6 of this Act, the persons serving as members of the  
23 Board of Fisheries on the day before the effective date of sec. 1 of this Act, and their  
24 successors, shall continue to serve on the board until July 1 following the confirmation by  
25 the legislature of at least two of the three persons appointed by the governor to serve on the  
26 Board of Fisheries as restructured by secs. 1 - 6 of this Act.

27 (c) Notwithstanding secs. 1 - 6 of this Act, the Board of Fisheries shall operate under  
28 the provisions of AS 16.05.221, 16.05.290, 16.05.320, and AS 39.25.110 as those provisions  
29 read on the day before the effective date of sec. 1 of this Act until July 1 following the  
30 confirmation by the legislature of at least two of the three persons appointed by the governor  
31 to serve on the Board of Fisheries as restructured by secs. 1 - 6 of this Act.

**1** \* **Sec. 9.** Sections 1 - 6 of this Act take effect on July 1 following the confirmation by the  
**2** legislature of at least two of the three persons appointed by the governor to serve on the Board  
**3** of Fisheries as restructured by secs. 1 - 6 of this Act.
