A BILL

FOR AN ACT ENTITLED

1 "An Act relating to the public school foundation program; and providing for an
2 effective date."

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 * **Section 1.** AS 14.17.025(b) is amended to read:

5 (b) In addition to the local contributions required under (a) of this section,
6 local contributions to a city or borough school district in a fiscal year may include no
7 more than the greater of

8 (1) the equivalent of a two mill tax levy on the full and true value of
9 the taxable real and personal property in the district as of January 1 of the second
10 preceding fiscal year, as determined by the Department of Community and Regional
11 Affairs under AS 14.17.140 and AS 29.45.110; or

12 (2) 19 [23] percent of the district's basic need for the fiscal year under
13 AS 14.17.021(b), as adjusted under AS 14.17.225(b).

14 * **Sec. 2.** AS 14.17.041 is amended by adding a new subsection to read:

1 (e) A district with an ADM of 850 or less that consists of one funding
2 community shall increase the elementary and secondary instructional units received
3 under (a) or (b) of this section by multiplying the instructional units by a percentage
4 determined under the following table:

District ADM	Percentage
1 - 250	1.12
251 - 525	1.08
526 - 850	1.06.
