A BILL

FOR AN ACT ENTITLED

1 "An Act amending the area within designated marine park units of the Alaska
2 state park system, and adding marine park units to the Alaska state park
3 system."

4 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

5 * **Section 1.** LEGISLATIVE FINDINGS AND STATEMENT OF PURPOSE. (a) The
6 legislature finds that

7 (1) marine parks promote and support recreation and tourism in the state by
8 maintaining fish and wildlife resources and lawful existing uses of these resources and by
9 protecting their natural, cultural, and scenic values; and

10 (2) by combining upland with the surrounding water, tideland, and submerged
11 land into a marine park, the state is able to ensure public anchorages and recreational beaches
12 will be managed as one unit with consistent development and regulations.

13 (b) It is the purpose of this Act to expand the marine park system in Lynn Canal
14 within the City and Borough of Juneau by the inclusion of the islands selected under the

1 Alaska Statehood Act from the Tongass National Forest for the purpose of community
2 recreation that have been tentatively approved or patented to the state.
