A BILL

FOR AN ACT ENTITLED

1 "An Act relating to memorial scholarship loans."

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 * **Section 1.** AS 14.43.300(b) is amended to read:

4 (b) A loan made under AS 14.43.250 - 14.43.325 may be used only as follows:

5 (1) a Michael Murphy memorial scholarship loan may be used only to
6 pursue a certificate or degree program in an accredited college or university in law
7 enforcement, law, probation and parole, or penology, or closely related fields;

8 (2) a Carroll L. "Butch" Swartz memorial scholarship loan may be used
9 only to pursue a degree program in an accredited college or university in criminal law,
10 criminology, corrections, police science and administration, juvenile justice, or other
11 fields closely related to criminal justice;

12 (3) a Harvey Golub memorial scholarship loan may be used only to
13 pursue a degree program in an accredited college or university in civil, mechanical,
14 electrical, electronic, petroleum, mining, traffic and transportation, sanitary, chemical,
15 or other recognized field of engineering;

1 (4) a Robert L. Thomas memorial scholarship loan may be used only
2 to pursue a degree program in an accredited college or university that will lead to a
3 career in education or public administration, or other closely related field;

4 (5) an A.W. (Winn) Brindle memorial scholarship loan may be used
5 only to pursue a certificate or degree program in an accredited school, college, or
6 university in fisheries, fishery science, fishery management, seafood processing, food
7 technology, or other closely related field; and

8 (6) a Nick Begich memorial scholarship loan may be used only to
9 pursue a degree program in an accredited college or university that will lead to a
10 career in education, public administration, government, or other closely related field.

11 * **Sec. 2.** AS 14.43.305(e) is amended to read:

12 (e) A recipient of a memorial scholarship loan under AS 14.43.250(b)(1) - (4)
13 or (6) who graduates from a degree program, **or for a loan under AS 14.43.250(b)(1)**
14 **from a certificate program,** shall receive forgiveness of one-fifth of loan indebtedness
15 for each one-year period the recipient is employed full time in Alaska in

16 (1) law-enforcement or related fields, if a recipient of a Michael
17 Murphy memorial scholarship loan;

18 (2) criminal law, criminal justice, or other closely related fields, if a
19 recipient of a Carroll L. "Butch" Swartz memorial scholarship loan;

20 (3) a recognized branch of the engineering profession or other closely
21 related fields, if a recipient of a Harvey Golub memorial scholarship loan;

22 (4) education or public administration, or other closely related field, if
23 a recipient of a Robert L. Thomas memorial scholarship loan; or

24 (5) education, public administration, government, or other closely
25 related field, if a recipient of a Nick Begich memorial scholarship loan.
