A BILL

FOR AN ACT ENTITLED

1 "An Act relating to children-in-need-of-aid matters and proceedings; relating to
2 child abuse and neglect; relating to kidnapping and the crime of endangering
3 the welfare of a child; relating to sentencing for certain crimes; relating to the
4 state medical examiner and reviews of child fatalities; relating to teacher
5 certification and convictions of crimes involving child victims; relating to
6 modification of child support orders by the child support enforcement agency;
7 relating to access to, confidentiality of, and release of certain information
8 concerning children, child abuse and neglect, and child fatalities; authorizing the
9 Department of Health and Social Services to enter into an interstate compact
10 concerning adoption and medical assistance for certain children with special
11 needs; relating to the review of cases involving certain children who are in the
12 custody of the state; authorizing the establishment of multidisciplinary child

1 protection teams and relating to their duties; relating to persons required to
 2 report suspected child abuse or neglect; relating to foster care and foster
 3 parents; relating to access to certain criminal justice information and licensure
 4 of certain child care facilities; amending Rule 218, Alaska Rules of Appellate
 5 Procedure; and amending Rules 3, 7, 10, 15, 18, 19, and 22, Alaska Child in
 6 Need of Aid Rules."

7 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

8 * **Section 1.** INTENT AND PURPOSE OF ACT. (a) The intent of this Act is to protect
 9 children from abuse and neglect without prohibiting the use of reasonable methods of parental
 10 discipline or prescribing a particular method of parenting.

11 (b) The purpose of this Act is to

12 (1) provide the legal mechanisms by which the state can use its resources for
 13 the best interest of children in this state; and

14 (2) override the court decisions in the following cases:

15 (A) Matter of J.L.F., 912 P.2d 1255 (Alaska 1996), In Re S.A., 912
 16 P.2d 1235 (Alaska 1996), and F.T. v. State, 862 P.2d 857 (Alaska 1993), concerning
 17 the standards to adjudicate a child in need of aid when a parent or caregiver is willing,
 18 but unable, to provide essential care for a child;

19 (B) A.M. v. State, 891 P.2d 815 (Alaska 1995), and Nada A. v. State,
 20 660 P.2d 436 (Alaska App. 1983), concerning the standards to terminate parental rights
 21 when a parent is incarcerated;

22 (C) R.J.M. v. State, 946 P.2d 855 (Alaska 1997), concerning the type
 23 of neglect necessary to adjudicate a child in need of aid under AS 47.10.

24 * **Sec. 2.** AS 10.06.961(a) is amended to read:

25 (a) Notwithstanding AS 13.46.085 or the appointment of a guardian of the
 26 property of the **child** [MINOR] under **AS 47.10.010** [AS 47.10.010(c)], when a **child**
 27 [MINOR] who is in the custody of this state under AS 47.10 or **a minor who is in the**
 28 **custody of this state under** AS 47.12 or of another state under a provision similar to

1 AS 47.10 or AS 47.12 becomes entitled to receive dividends or other distributions
 2 resulting from the ownership of stock or a membership in a corporation organized
 3 under this chapter and under 43 U.S.C. 1601 - 1641 (Alaska Native Claims Settlement
 4 Act), the corporation paying the dividends or making the other distributions shall retain
 5 the dividends and other distributions in an interest bearing account for the benefit of
 6 the **child or** minor during the state custody.

8 (a) A person commits the crime of kidnapping if

9 (1) the person restrains another with intent to

10 (A) hold the restrained person for ransom, reward, or other
 11 payment;

12 (B) use the restrained person as a shield or hostage;

13 (C) inflict physical injury upon or sexually assault the restrained
 14 person or place the restrained person or a third person in apprehension that any
 15 person will be subjected to serious physical injury or sexual assault;

16 (D) interfere with the performance of a governmental or
 17 political function;

18 (E) facilitate the commission of a felony or flight after
 19 commission of a felony; [OR]

20 **(F) commit an offense in violation of AS 11.41.434 -**
 21 **11.41.438 upon the restrained person or place the restrained person or a**
 22 **third person in apprehension that a person will be subject to an offense in**
 23 **violation of AS 11.41.434 - 11.41.438; or**

24 (2) the person restrains another

25 (A) by secreting and holding the restrained person in a place
 26 where the restrained person is not likely to be found; or

27 (B) under circumstances which expose the restrained person to
 28 a substantial risk of serious physical injury.

30 (d) In a prosecution for kidnapping, it is an affirmative defense which reduces
 31 the crime to a class A felony that the defendant voluntarily caused the release of the

1 victim alive in a safe place before arrest, or within 24 hours after arrest, without
 2 having caused serious physical injury to the victim and without having engaged in
 3 conduct described in AS 11.41.410(a), [OR] 11.41.420, 11.41.434, or 11.41.436.

4 * **Sec. 5.** AS 11.51.100 is repealed and reenacted to read:

5 **Sec. 11.51.100. Endangering the welfare of a child in the first degree.** (a)

6 A person commits the crime of endangering the welfare of a child in the first degree
 7 if, being a parent, guardian, or other person legally charged with the care of a child
 8 under 16 years of age, the person

9 (1) intentionally deserts the child in a place under circumstances
 10 creating a substantial risk of physical injury to the child;

11 (2) leaves the child with another person who is not a parent, guardian,
 12 or lawful custodian of the child knowing that the person

13 (A) is registered or required to register as a sex offender under
 14 AS 12.63 or a law or ordinance in another jurisdiction with similar
 15 requirements;

16 (B) has been charged by complaint, information, or indictment
 17 with a violation of AS 11.41.410 - 11.41.455 or a law or ordinance in another
 18 jurisdiction with similar elements; or

19 (C) has been charged by complaint, information, or indictment
 20 with an attempt, solicitation, or conspiracy to commit a crime described in (B)
 21 of this paragraph; or

22 (3) leaves the child with another person knowing that the person has
 23 previously physically mistreated or had sexual contact with any child, and the other
 24 person causes physical injury or engages in sexual contact with the child.

25 (b) In this section, "physically mistreated" means

26 (1) having committed an act punishable under AS 11.41.100 -
 27 11.41.250; or

28 (2) having applied force to a child that, under the circumstances in
 29 which it was applied, or considering the age or physical condition of the child,
 30 constitutes a gross deviation from the standard of conduct that a reasonable person
 31 would observe in the situation because of the substantial and unjustifiable risk of

- 1 (A) death;
- 2 (B) serious or protracted disfigurement;
- 3 (C) protracted impairment of health;
- 4 (D) loss or impairment of the function of a body member or
- 5 organ;
- 6 (E) substantial skin bruising, burning, or other skin injury;
- 7 (F) internal bleeding or subdural hematoma;
- 8 (G) bone fracture; or
- 9 (H) prolonged or extreme pain, swelling, or injury to soft tissue

10 (c) Endangering the welfare of a child in the first degree under (a)(1) or (2) of
 11 this section is a class C felony.

12 (d) Endangering the welfare of a child in the first degree under (a)(3) of this
 13 section is a

- 14 (1) class B felony if the child dies;
- 15 (2) class C felony if the child suffers sexual contact, sexual penetration,
 16 or serious physical injury; or
- 17 (3) class A misdemeanor if the child suffers physical injury.

20 (a) A person commits the crime of endangering the welfare of a child in the second
 21 degree if the person, while caring for a child under 10 years of age,

22 (1) causes or allows the child to enter or remain in a dwelling or vehicle
 23 in which a controlled substance is stored in violation of AS 11.71; or

24 (2) is impaired by an intoxicant, whether or not prescribed for the
 25 person under AS 17.30, and there is no third person who is at least 12 years of age and
 26 not impaired by an intoxicant present to care for the child.

27 (b) In this section,

28 (1) "impaired" means that a person is unconscious or a person is
 29 physically or mentally affected so that the person does not have the ability to care for
 30 the basic safety or personal needs of a child with the caution characteristic of a sober
 31 person of ordinary prudence;

2 (c) Endangering the welfare of a child in the second degree is a violation.

4 (23) the defendant is convicted of an offense specified in AS 11.71 and

5 (A) the offense involved the delivery of a controlled substance
6 under circumstances manifesting an intent to distribute the substance as part of
7 a commercial enterprise; **or**

8 (B) at the time of the conduct resulting in the conviction, the
9 defendant was caring for or assisting in the care of a child under 10 years
10 of age;

11 * **Sec. 8.** AS 12.65.005(a) is amended to read:

12 (a) Unless the person has reasonable grounds to believe that notice has already
13 been given, a person who attends a death or has knowledge of a death, in addition to
14 notifying a peace officer, shall immediately notify the state medical examiner when the
15 death appears to have

16 (1) been caused by unknown or criminal means, during the commission
17 of a crime, or by suicide, accident, or poisoning;

18 (2) occurred under suspicious or unusual circumstances or occurred
19 suddenly when the decedent was in apparent good health;

20 (3) been unattended by a practicing physician or occurred less than 24
21 hours after the deceased was admitted to a medical facility;

22 (4) been associated with a diagnostic or therapeutic procedure;

23 (5) resulted from a disease that constitutes a threat to public health;

24 (6) been caused by a disease, injury, or toxic agent resulting from
25 employment;

26 (7) occurred in a jail or corrections facility owned or operated by the
27 state or a political subdivision of the state or in a facility for the placement of persons

12 (e) The state medical examiner shall facilitate the formation of local, regional,
 13 or district child fatality review teams to assist local, regional, and district medical
 14 examiners in determining the cause and manner of deaths of children under 18 years
 15 of age. If a team is formed under this subsection, the team shall have the same access
 16 to information, confidentiality requirements, and immunity as provided to the state child
 17 fatality review team under AS 12.65.140. A meeting of a team formed under this
 18 subsection is closed to the public and not subject to the provisions of AS 44.62.310 and
 19 44.62.312. A review by a local, regional, or district child fatality review team does not
 20 relieve the state child fatality review team under AS 12.65.120 of the responsibility for
 21 reviewing a death under AS 12.65.130. A person on a local, regional, or district child
 22 fatality review team is not eligible to receive compensation from the state for service
 23 on the team, but is eligible for travel expenses and per diem from the Department of
 24 Health and Social Services under AS 39.20.180. A person on a team formed under this
 25 subsection serves at the pleasure of the state medical examiner.

27 **Sec. 12.65.120. State child fatality review team.** (a) The state child fatality
 28 review team is established in the Department of Health and Social Services to assist the
 29 state medical examiner. The team is composed of

30 (1) the following persons, or that person's designee:

31 (A) the state medical examiner;

1 (B) a state prosecutor with experience in homicide prosecutions,
2 appointed by the attorney general;

3 (C) an investigator with the state troopers who has experience
4 in conducting investigations of homicide, child abuse, or child neglect,
5 appointed by the commissioner of public safety;

6 (D) a social worker with the Department of Health and Social
7 Services who has experience in conducting investigations of child abuse and
8 neglect, appointed by the commissioner of health and social services;

9 (2) the following persons, or that person's designee, appointed by the
10 commissioner of health and social services:

11 (A) a physician licensed under AS 08.64 who

12 (i) specializes in neonatology or perinatology; or

13 (ii) is certified by the American Board of Pediatrics;

14 (B) a municipal law enforcement officer with experience in
15 conducting investigations of homicide, child abuse, or child neglect;

16 (C) other persons, including educators, whose experience and
17 expertise would, as determined by the commissioner of health and social
18 services, contribute to the effectiveness of the team.

19 (b) A team member is not eligible to receive compensation from the state for
20 service on the team. A member appointed under (a)(2) of this section

21 (1) is eligible for travel expenses and per diem from the Department of
22 Health and Social Services under AS 39.20.180; and

23 (2) serves at the pleasure of the commissioner of health and social
24 services.

25 (c) In addition to the persons specified in (a) of this section, the team may
26 invite a person to participate as a member of the team if the person has expertise that
27 would be helpful to the team in a review of a specific death. A person participating
28 under this subsection is eligible only for travel expenses and per diem from the
29 Department of Health and Social Services under AS 39.20.180.

30 (d) The state medical examiner serves as chair of the team.

31 **Sec. 12.65.130. State child fatality review team duties.** (a) The state child

1 fatality review team shall

2 (1) assist the state medical examiner in determining the cause and
3 manner of the deaths in this state of children under 18 years of age;

4 (2) unless the child's death is currently being investigated by a law
5 enforcement agency, review a report of a death of a child within 48 hours of the report
6 being received by the medical examiner if

7 (A) the death is of a child under 10 years of age;

8 (B) the deceased child, a sibling, or a member of the deceased
9 child's household

10 (i) is in the legal or physical custody of the state under
11 AS 47 or under similar custody of another state or political subdivision
12 of a state; or

13 (ii) has been the subject of a report of harm under
14 AS 47.17 or a child abuse or neglect investigation by the Department of
15 Health and Social Services or by a similar child protective service in this
16 or another state;

17 (C) a protective order under AS 18.66.100 or 18.66.110 has been
18 in effect during the previous year in which the petitioner or respondent was a
19 member of the deceased child's immediate family or household; or

20 (D) the child's death occurred in a mental health institution,
21 mental health treatment facility, foster home, or other residential or child care
22 facility, including a day care facility;

23 (3) review records concerning

24 (A) abuse or neglect of the deceased child or another child in the
25 deceased child's household;

26 (B) the criminal history or juvenile delinquency of a person who
27 may have caused the death of the child and of persons in the deceased child's
28 household; and

29 (C) a history of domestic violence involving a person who may
30 have caused the death of the child or involving persons in the deceased child's

13 (3) develop a model protocol for the investigation of deaths of children;

15 (4) periodically issue reports to the public containing statistical data and
16 other information that does not violate federal or state law concerning confidentiality
17 of the children and their families involved in the reviews; these reports may include

18 (A) identification of trends, patterns, and risk factors in deaths
19 of the children;

20 (B) analyses of the incidence and causes of deaths of children
21 in this state;

22 (C) recommendations for improving the coordination of
23 government services and investigations; and

24 (D) recommendations for prevention of future deaths of children.

26 (a) The state child fatality review team and its members shall have access to all
27 information and records to which the state medical examiner has access under this
28 chapter. The state child fatality review team and its members shall maintain the
29 confidentiality of information and records concerning deaths under review, except when
30 disclosures may be necessary to enable the team to carry out its duties under this
31 chapter. However, the team and its members may not disclose a record that is

1 confidential under federal or state law.

2 (b) Except for public reports issued by the team, records, and other information
3 collected by the team or a member of the team related to duties under this chapter are
4 confidential and not subject to public disclosure under AS 09.25.100 - 09.25.220.

5 (c) Meetings of the state child fatality review team are closed to the public and
6 are not subject to the provisions of AS 44.62.310 and 44.62.312.

7 (d) The determinations, conclusions, and recommendations of the state child
8 fatality review team, or its members, are not admissible in a civil or criminal
9 proceeding. Members may not be compelled to disclose their determinations,
10 conclusions, recommendations, discussions, or thought processes through discovery or
11 testimony in any civil or criminal proceeding. Records and information collected by
12 the state child fatality review team are not subject to discovery or subpoena in
13 connection with a civil or criminal proceeding.

14 (e) Notwithstanding (d) of this section, the state medical examiner may testify
15 in a civil or criminal proceeding even though the death was reviewed by the state child
16 fatality review team under AS 12.65.130 and information received from the review
17 formed a basis of the state medical examiner's testimony.

18 (f) A person who is a member or an employee of, or who furnishes services to
19 or advises, the state child fatality review team is not liable for damages or other relief
20 in an action brought by reason of the performance of a duty, a function, or an activity
21 of the review team.
