A BILL

FOR AN ACT ENTITLED

**1 "An Act merging certain departments in the executive branch of state
2 government; changing the names of certain departments in the executive branch
3 of state government; transferring duties among departments and offices in the
4 executive branch of state government; providing that certain discretionary duties
5 formerly performed by the Department of Community and Regional Affairs are
6 mandatory in the department to which those duties are transferred; relating to
7 the licensing of child care facilities; relating to the division of vocational
8 rehabilitation; relating to the Alaska Human Resource Investment Council;
9 adjusting the membership of certain multi-member bodies; providing that a
10 certain commissioner may designate department employees to serve in the
11 commissioner's place on a board, council, or similar entity; providing for advice
12 to be given by a department head to the governor and other commissioners on**

1 the delivery of government services to rural areas and providing for
 2 recommendations to be made to the governor and other commissioners by that
 3 same commissioner about policy changes that would affect rural governments and
 4 rural affairs; relating to the federal community development quota program;
 5 eliminating references to the division of tourism; eliminating a reference to
 6 manpower training programs; eliminating references to the director and deputy
 7 director of international trade; eliminating the requirement for a local advisory
 8 committee for consideration of rural electrification loans; and providing for an
 9 effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. AS 09.25.110(e) is amended to read:

12 (e) Notwithstanding other provisions of this section to the contrary, the Bureau
 13 of Vital Statistics **and** [,] the library archives in the Department of Education [, AND
 14 THE DIVISION OF BANKING, SECURITIES, AND CORPORATIONS IN THE
 15 DEPARTMENT OF COMMERCE AND ECONOMIC DEVELOPMENT] may
 16 continue to charge the same fees that they **were** [ARE] charging on September 25,
 17 1990, for performing record searches, and may increase the fees as necessary to
 18 recover agency expenses on the same basis that **was** [IS] used by the agency
 19 immediately before September 25, 1990. **Notwithstanding other provisions of this**
 20 **section to the contrary, the division of banking, securities, and corporations in the**
 21 **Department of Community and Economic Development may continue to charge**
 22 **the same fees that the former Department of Commerce and Economic**
 23 **Development was charging on the effective date of this bill section for performing**
 24 **record searches and may increase the fees as necessary to recover agency expenses**
 25 **on the same basis that was used by the former Department of Commerce and**
 26 **Economic Development immediately before the effective date of this bill section.**

2 * **Sec. 3.** AS 11.61.195(a) is amended to read:

3 (a) A person commits the crime of misconduct involving weapons in the
4 second degree if the person knowingly

5 (1) possesses a firearm during the commission of an offense under
6 AS 11.71.010 - 11.71.040;

7 (2) violates AS 11.61.200(a)(1) and is within the grounds of or on a
8 parking lot immediately adjacent to

9 (A) a public or private preschool, elementary, junior high, or
10 secondary school without the permission of the chief administrative officer of
11 the school or district or the designee of the chief administrative officer; or

12 (B) a center, other than a private residence, licensed under
13 AS 14.37, AS 47.33, or AS 47.35 or recognized by the federal government for
14 the care of children; or

15 (3) discharges a firearm at or in the direction of

16 (A) a building with reckless disregard for a risk of physical

20 (a) A person commits the crime of misconduct involving weapons in the fifth
21 degree if the person

22 (1) knowingly possesses a deadly weapon, other than an ordinary
23 pocket knife or a defensive weapon, that is concealed on the person;

24 (2) knowingly possesses a loaded firearm on the person in any place
25 where intoxicating liquor is sold for consumption on the premises;

26 (3) being an unemancipated minor under 16 years of age, possesses a
27 firearm without the consent of a parent or guardian of the minor;

28 (4) knowingly possesses a firearm

29 (A) within the grounds of or on a parking lot immediately
30 adjacent to a center, other than a private residence, licensed under AS 14.37,
31 AS 47.33, or AS 47.35 or recognized by the federal government for the care

1 of children; or

10 **Sec. 14.20.165. Restoration of tenure rights.** A teacher who held tenure
 11 rights and who was retired due to disability under AS 14.25.130, but whose disability
 12 (1) has been removed, and the removal of that disability is certified by a competent
 13 physician following a physical or mental examination, or (2) has been compensated for
 14 by rehabilitation or other appropriate restorative education or training, and that
 15 rehabilitation or restoration to health has been certified by the division of vocational
 16 rehabilitation of the **Department of Labor and Workforce Development**
 17 [DEPARTMENT], shall be restored to full tenure rights in the district from which the
 18 teacher was retired, at such time as an opening for which the teacher is qualified
 19 becomes available.

21 (b) When required by any of the Acts described in AS 14.35.010, the board
 22 shall

23 (1) prepare, submit, and supervise the administration of the plans for
 24 vocational education [AND VOCATIONAL REHABILITATION];

25 (2) select a state director of vocational education;

26 (3) establish the minimum qualifications for teachers, supervisors, or
 27 directors;

28 (4) determine the prorated basis on which money shall be available for
 29 the salary and necessary travel expenses of the state director of vocational education;

30 (5) consider the advice of the Alaska Human Resource Investment
 31 Council established by **AS 23.15.550** [AS 44.19.620] regarding employment training

1 needs and advise that council in the development of vocational education programs.

2 * **Sec. 7.** AS 14 is amended by adding a new chapter to read:

3 **Chapter 37. Licensure of Child Care Facilities.**

4 **Sec. 14.37.005. Purpose; applicability.** (a) The purpose of this chapter is
5 to establish and maintain standard levels for services offered to children in child care
6 facilities. The legislature recognizes the responsibility of parents to select and monitor
7 caregivers for their children in order to ensure a reasonably safe and developmentally
8 appropriate child care environment. The child care licensing procedures in this chapter
9 are intended to reduce predictable risk of harm to children and to provide support
10 services to those providing child care services.

11 (b) This chapter and regulations adopted under this chapter apply to facilities

12 (1) for which licensure is required by or under AS 14.37.015; or

13 (2) that are exempt under AS 14.37.015 from licensure but for which
14 a license is issued under AS 14.37.015(c).

15 **Sec. 14.37.010. Powers of department.** (a) The department may

16 (1) license and supervise child care facilities;

17 (2) investigate applicants, licensees, and persons that the department
18 reasonably believes are operating a facility without a license or certification in
19 violation of this chapter;

20 (3) adopt regulations to implement the provisions of this chapter,
21 including regulations establishing certification and licensure procedures, standards, and
22 fees; establishing requirements for operation of facilities licensed under this chapter;
23 and distinguishing between types of child care facilities;

24 (4) enter into agreements with private entities, municipalities, or
25 individuals to investigate and make recommendations to the department for the
26 licensing and supervision of child care facilities under procedures and standards of
27 operation established by the department.

28 (b) The department shall, within 90 days after receiving a written request that
29 it do so, delegate its powers relating to child care facilities under this chapter to a
30 municipality that has adopted an ordinance providing for child care licensing under
31 home rule powers under AS 29.10.010 or as authorized under AS 29.35.200 -

1 29.35.210. A municipality to which these powers have been delegated may adopt, by
 2 ordinance, additional requirements for child care facilities operating within its
 3 boundaries if the requirements meet or exceed the requirements adopted by the
 4 department.

5 **Sec. 14.37.015. License required; exemptions.** (a) A person may not operate
 6 a child care facility without a license issued under this chapter unless that facility is
 7 exempt from licensure. The following facilities are exempt:

8 (1) a facility in which child care is regularly provided and each child's
 9 parent is on the premises within reasonable proximity and accessibility to the child;

10 (2) a facility located on a United States Department of Defense or
 11 United States Coast Guard installation that is located on federal property;

12 (3) a recreational program that children are allowed to attend and in
 13 which the program assumes no responsibility for care of the children;

14 (4) a daytime therapeutic program of supervised, educational, and
 15 rehabilitative services for children with special needs or behavioral problems;

16 (5) a program that is primarily educational and that

17 (A) is certified as a pre-elementary school under department
 18 regulations adopted under AS 14.07.020;

19 (B) serves children three years of age or older and is exempt
 20 from the department pre-elementary school regulations; or

21 (C) is operated as a headstart preschool that is required to meet
 22 the standards established under 42 U.S.C. 9836a;

23 (6) a temporary facility providing care for less than five continuous
 24 weeks;

25 (7) a facility regularly providing child care to four or fewer children
 26 unrelated to the caregiver;

27 (8) a facility in which the caregiver is a relative of all of the children.

28 (b) In addition to facilities that, under this section, are exempt from licensure,
 29 the department, by regulation, may provide for additional exemptions that the
 30 department considers appropriate.

31 (c) A person may apply for a license for a facility that is exempt from

1 licensure under this section. The department may issue a license to an applicant under
2 this subsection if the applicant meets the requirements of this chapter and regulations
3 adopted under this chapter.

4 **Sec. 14.37.017. Application for license.** (a) Application for a license to
5 operate a child care facility must be made to the department on a form provided by
6 the department and must be accompanied by all applicable fees established by the
7 department under AS 14.37.010(a)(3).

8 (b) An application submitted under this section must contain at least the
9 following information:

10 (1) the name and address of the applicant and, if the applicant is a
11 corporation, partnership, association, or another form of organization, the name,
12 address, and title of each individual who has an ownership or management interest in
13 the facility; if the applicant is an individual, the application must include the name,
14 age, and driver's license number, if any, of each member of the individual's
15 household;

16 (2) the name, physical location, and mailing address of the facility for
17 which the license is sought;

18 (3) the name and address of the administrator of the facility, if any;

19 (4) evidence that the administrator is an adult with sufficient
20 experience, training, or education to fulfill the duties of an administrator;

21 (5) a release for the administrator and for each other person who is 16
22 years of age or older, as specified by the department by regulation, who will have
23 contact with individuals served by the facility authorizing the department to review all
24 federal, state, and municipal criminal justice information, whether of this state, of a
25 municipality of this state, or of another jurisdiction, medical records, licensing records,
26 and protective services records, identified in regulations adopted under this chapter,
27 that are relevant to the person who is the subject of the release;

28 (6) the number of individuals that will be served in the facility;

29 (7) the type of facility for which the license is sought;

30 (8) copies of all inspection reports and approvals required by state fire
31 prevention and environmental health and safety authorities for operation of the facility,

1 including any variances granted by these authorities;

2 (9) a plan of operation, as required by the department by regulation;

3 (10) a staffing plan that describes the number of people who will work
4 at the facility, staff qualifications, a description of each person's responsibilities, and
5 a supervision schedule for the children in care that meets the requirements established
6 by the department by regulation;

7 (11) evidence that the applicant has completed orientation or training
8 required by the department by regulation; and

9 (12) other information required by the department, by regulation, in
10 order to monitor compliance with this chapter and regulations adopted under this
11 chapter.

12 **Sec. 14.37.020. Provisional license; biennial license.** (a) The department
13 shall issue a provisional license to a new facility that applies under AS 14.37.017 if,
14 after inspection and investigation, the department determines that the application and
15 plan of operation for the facility meet the requirements of this chapter and regulations
16 adopted under this chapter. A provisional license is valid for a period not to exceed
17 one year. The department may extend a provisional license for one additional period
18 not to exceed one year.

19 (b) Before expiration of a provisional license issued under (a) of this section,
20 the department shall inspect and investigate the facility in order to determine whether
21 the facility is operating under the provisional license in compliance with this chapter
22 and applicable regulations.

23 (c) Before expiration of a provisional license, the department shall issue a
24 biennial license for the facility if (1) after inspection and investigation under (b) of this
25 section, the department finds that the facility is operating in compliance with and
26 meets the licensure requirements of this chapter and regulations adopted under this
27 chapter; (2) none of the grounds for revocation set out in AS 14.37.130(a)(2) exist; and
28 (3) all applicable fees have been paid. The department shall prepare a summary report
29 of its findings and recommendations for issuance of a biennial license.

30 (d) The issuance of a license by the department does not obligate the
31 department to support the facility financially.

1 **Sec. 14.37.025. Denial of license; right to appeal.** (a) If the department
 2 denies an application for a license or decides not to issue a biennial license, the
 3 department shall hand deliver to the prospective licensee, or mail to the prospective
 4 licensee by certified mail, return receipt requested, a notice of denial of licensure. The
 5 notice must contain a summary of the department's reasons for denial of the license
 6 and a form for requesting a hearing under (b) of this section.

7 (b) A prospective licensee who was denied licensure may appeal the
 8 department's decision by requesting a hearing, on the form provided by the
 9 department, within 15 days after receipt of the notice of denial of licensure.

10 **Sec. 14.37.027. Variances.** (a) The department may grant to an applicant for
 11 a license under this chapter, or to a licensee, a variance from a requirement of this
 12 chapter or a regulation adopted under this chapter if that person submits to the
 13 department, on a form provided by the department, a complete variance request as
 14 required by this section. A variance may be granted if

15 (1) the applicant or licensee proposes an alternative means, acceptable
 16 to the department, to satisfy the intent of the requirement for which the variance is
 17 requested; and

18 (2) the health and safety of children is adequately protected.

19 (b) A request for a variance must contain the following information:

20 (1) the statute or regulation from which the variance is sought;

21 (2) the reasons why the variance is needed;

22 (3) the period of time for which the variance is requested;

23 (4) the proposed alternative means of satisfying the intent of the
 24 requirement for which the variance is requested;

25 (5) a statement as to how the health and safety of children will be
 26 protected during the period of the variance; and

27 (6) assurance that the conditions of the facility do not present an
 28 imminent danger to the health or safety of individuals served by the facility.

29 (c) To evaluate a request for a variance, the department shall take one or more
 30 of the following actions:

31 (1) investigate the statements in the request;

- 1 (2) inspect the facility;
 2 (3) schedule a conference with the applicant or licensee regarding the
 3 variance request.

4 (d) The department's decision approving or denying a variance must be in
 5 writing, and the department shall provide a copy of the decision to the person
 6 requesting the variance. If the department grants the variance, the decision must state
 7 the term of and conditions of the variance.

8 (e) If an applicant or licensee violates a condition of a variance granted under
 9 this section, the variance is terminated.

10 **Sec. 14.37.029. Content of license; posting.** (a) A license issued under this
 11 chapter must state

- 12 (1) the period of time during which the license is in effect;
 13 (2) the name of the facility;
 14 (3) the type of facility;
 15 (4) the name of the licensee;
 16 (5) the location and mailing address of the facility;
 17 (6) the number and age range of children that the facility may have in
 18 care at any time;
 19 (7) all conditions set by the department;
 20 (8) variances approved by the department for the duration of the
 21 license; and
 22 (9) the address and phone number of the nearest department office that
 23 is responsible for administering this chapter or of the department representative
 24 responsible for evaluating that facility under AS 14.37.010(a)(4).

25 (b) A licensee shall post the license in a conspicuous place in the facility,
 26 visible to individuals in care and their families and to facility staff. If the department
 27 has approved a variance that is not stated on the license, the licensee shall post a copy
 28 of the variance near the license.

29 **Sec. 14.37.033. Licenses not transferable.** A license may be issued under
 30 this chapter only for the location and person named in the application. A license
 31 issued under this chapter may not be transferred to another person or location.

1 **Sec. 14.37.037. Orientation and training.** The department, by regulation,
2 may require that an applicant or licensee complete orientation or training to assist that
3 person in operating under the license.

4 **Sec. 14.37.039. Records required.** (a) In accordance with regulations
5 adopted by the department, a licensee shall keep the records regarding each individual
6 in its care that are necessary to show compliance with this chapter and regulations
7 adopted under this chapter.

8 (b) The department's licensing records, with the names of all individuals in
9 care and parents of minors in care deleted to protect the confidentiality of those
10 individuals, are available for public inspection, except for

11 (1) material made confidential by state or federal statutes or regulations;

12 (2) material that is part of an uncompleted licensing or complaint
13 investigation;

14 (3) records that would deprive an applicant, licensee, or other person
15 of a fair and impartial hearing; and

16 (4) records for which the department determines that disclosure would
17 constitute an unwarranted invasion of personal privacy.

18 (c) A government agency that provides funding to a facility licensed under this
19 chapter may have access to that facility's records in order to conduct an audit.

20 **Sec. 14.37.043. Monitoring; investigation.** (a) By the first anniversary of
21 the effective date of a biennial license, including a renewed biennial license, the
22 licensee shall submit an annual self-monitoring report to the department. The
23 department shall specify, by regulation, the contents of the report.

24 (b) To encourage parents of children in child care facilities to become involved
25 in day-to-day monitoring of the care provided by the facilities, the department shall
26 require licensees to give to parents of children in child care in the licensee's facility
27 a summary of the regulatory requirements that apply to the facility and the
28 department's or department representative's telephone contact number for reporting a
29 concern regarding child care. The department also may provide notice of the
30 telephone contact numbers for reporting child care concerns.

31 (c) The department may conduct an investigation, including announced or

1 unannounced on-site inspections, for ongoing monitoring or to assist in its review of
2 an annual self-monitoring report.

3 **Sec. 14.37.045. Biennial license renewal.** (a) At least 90 days before the
4 expiration date of a biennial license, a licensee who wishes to remain licensed shall
5 submit, on a form provided by the department, an application for renewal of the
6 license and any associated variances.

7 (b) Before expiration of a biennial license, the department or its representative
8 shall inspect a facility that is the subject of a renewal application.

9 (c) The department shall renew a biennial license if the department finds that

10 (1) the licensee

11 (A) either is in compliance with this chapter and regulations
12 adopted under this chapter or is substantially in compliance and has
13 implemented a plan of correction, approved by the department, that is designed
14 to bring the facility into full compliance; and

15 (B) has maintained the facility in good repair and is in
16 compliance with all state fire safety and environmental health and safety code
17 requirements;

18 (2) the ground for revocation set out in AS 14.37.130(a)(2) does not
19 exist; and

20 (3) all applicable fees have been paid.

21 (d) If the licensee submits a renewal application within the time period
22 required by the department by regulation, but the department is unable to complete its
23 review before the expiration date of the biennial license, the license is automatically
24 extended for six months or until the department completes its review and either
25 approves or denies the application, whichever occurs first.

26 (e) If the department decides to approve an application for renewal, but finds
27 that the applicant is not in compliance with a provision of this chapter, a regulation
28 adopted under this chapter, or a condition on the license, the department, as a
29 condition on the renewed biennial license, shall require the applicant to correct any
30 violations and provide the department with verification of compliance.

31 (f) If the department denies an application for renewal, it shall provide the

1 applicant with a notice of denial of application. The notice must contain a written
 2 statement of the reasons for denial and a form for requesting a hearing under (g) of
 3 this section.

4 (g) An applicant whose application is denied may appeal the department's
 5 decision, on the form provided by the department, by requesting a hearing within 15
 6 days after receipt of the notice of denial of application.

7 **Sec. 14.37.047. Notice of changes.** (a) A licensee shall provide the
 8 department with written notice of a change of mailing address at least 14 days before
 9 the effective date of the change.

10 (b) A licensee shall notify the department within 24 hours after having
 11 knowledge of a conviction or indictment, presentment, or charging by information or
 12 complaint of an administrator, regular volunteer, staff person, or member of the
 13 licensee's household for a violation of the following laws or the laws of another
 14 jurisdiction with similar elements:

15 (1) offenses against the family and vulnerable adults under AS 11.51;

16 (2) perjury under AS 11.56.200;

17 (3) offenses included in the definition of "serious offense" under
 18 AS 12.62.900.

19 (c) A licensee shall notify the department at least 20 days before the effective
 20 date of a decision to relinquish the license.

21 (d) A licensee shall notify the department at least 20 days before the date on
 22 which the licensee wishes to change the number of children in care or hours of
 23 operation.

24 (e) A licensee shall notify the department no later than one day after signing
 25 a contract for sale of the licensed facility.

26 (f) A licensee shall notify the department at least 30 days before the licensee
 27 wishes to change the location of the facility.

28 **Sec. 14.37.105. Complaints.** (a) A person who believes that a provision of
 29 this chapter, a regulation adopted under this chapter, or a condition of a license issued
 30 under this chapter has been violated may file a verbal or written complaint with the
 31 department.

1 (b) The department shall investigate all complaints filed under this section
2 unless the department reasonably concludes that the complaint is without merit.

3 (c) After an investigation under this section, the department shall prepare a
4 written report of investigation and shall mail a copy to the licensee or other person
5 who is the subject of the complaint, and to the complainant if requested. If the
6 department determines that a violation of this chapter, a regulation adopted under this
7 chapter, or a condition of a license issued under this chapter has occurred, the
8 department's report of investigation must contain the following:

9 (1) a description of the violation;

10 (2) a citation to the provision of this chapter or the regulation that has
11 been violated, if applicable; and

12 (3) either

13 (A) a date by which the violation must be corrected and a
14 verification of compliance submitted to the department; or

15 (B) a plan of correction.

16 (d) A licensee may submit to the department a written response regarding a
17 report of investigation relating to that facility. The department shall retain the written
18 response in the licensing file.

19 (e) A licensee may not take retaliatory action against a person who files a
20 complaint. A complainant against whom retaliatory action has been taken may recover
21 treble damages in a civil action upon a showing that the action was taken in retaliation
22 for the filing of a complaint.

23 **Sec. 14.37.110. Investigations; search warrants.** (a) An applicant for a
24 license, or a licensee, shall cooperate with the department for purposes of licensing
25 investigations, investigations relating to ongoing monitoring of the facility, or
26 investigations under AS 14.37.105 by

27 (1) permitting representatives of the department to inspect the facility,
28 review records, interview staff, and interview individuals in care; and

29 (2) providing to the department information and documentation
30 requested by the department to determine compliance with this chapter and regulations
31 adopted under this chapter.

1 (b) Following an investigation relating to ongoing monitoring of a facility or
 2 relating to a facility that the department believes is operating without a license in
 3 violation of this chapter, the department shall prepare and distribute a written report
 4 of investigation as described in AS 14.37.105(c), and the facility may submit a
 5 response as described in AS 14.37.105(d).

6 (c) The department may seek a search warrant to inspect a facility if

7 (1) the department has probable cause to believe that the facility is
 8 operating without a license in violation of this chapter and the facility operator refuses
 9 to allow an inspection by the department; or

10 (2) the licensee refuses to allow an inspection of the facility by the
 11 department.

12 **Sec. 14.37.120. Enforcement actions.** (a) During an investigation under this
 13 chapter, the department may, by written notice, suspend operations of the facility if the
 14 department has reasonable cause to believe that a violation is occurring that presents
 15 an imminent danger to the health or safety of the individuals in care. A suspension
 16 under this subsection continues for the time period set by the department and may
 17 continue until the department issues a report of investigation under AS 14.37.105(c)
 18 or 14.37.110(b).

19 (b) If, after an investigation under this chapter, the department has determined
 20 that a violation of this chapter or a regulation adopted under this chapter has occurred
 21 or a ground for revocation or nonrenewal set out in AS 14.37.130 exists, has issued
 22 a report of investigation under AS 14.37.105(c) or 14.37.110(b), and has determined
 23 that voluntary compliance or a plan of correction is not appropriate, the department
 24 may take one or more of the following enforcement actions as the department
 25 considers appropriate:

26 (1) delivery of a warning notice to the licensee or other person who is
 27 the subject of the investigation;

28 (2) modification of the term of an existing license or reduction of the
 29 number of children for whom care can be provided;

30 (3) suspension of operations of the facility for a period of time set by
 31 the department;

1 (4) suspension of new enrollment in the facility for a period of time set
2 by the department;

3 (5) nonrenewal of the license;

4 (6) revocation of the license;

5 (7) issuance of an order requiring immediate closure of the facility;
