A BILL

FOR AN ACT ENTITLED

1 "An Act appropriating amounts to cover the fiscal year 2001 monetary terms of
2 the collective bargaining agreements for employees of the University of Alaska and
3 the fiscal year 2001 salary and benefit adjustments for university employees who
4 are not members of a collective bargaining unit; appropriating amounts to cover
5 the fiscal year 2001 monetary terms of all executive branch collective bargaining
6 agreements and the fiscal year 2001 salary and benefit adjustments for elected
7 officials, officers, and employees of the legislative, judicial, and executive branches
8 who are not members of a collective bargaining unit; and providing for an
9 effective date."

10 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

11 * **Section 1.** EXECUTIVE BRANCH. (a) Collective Bargaining Agreements. The sum
12 of \$20,335,700 is appropriated from the funding sources listed in (d) of this section to the

1 Office of the Governor, office of management and budget, for the fiscal year ending June 30,
2 2001, to implement the monetary terms of the following collective bargaining agreements:

3 COLLECTIVE BARGAINING AGREEMENT

4 (1) Alaska Public Employees Association, for the Supervisory Unit;

5 (2) Alaska State Employees Association, for the General Government Unit;

6 (3) Alaska Vocational Technical Center Teachers Association representing
7 teachers at the Alaska Vocational Technical Center;

8 (4) Alyeska Correspondence School Education Association, representing
9 teachers at the Alyeska Central School;

10 (5) Confidential Employees Association;

11 (6) Inlandboatmen's Union of the Pacific, representing the unlicensed marine
12 unit;

13 (7) International Organization of Masters, Mates, and Pilots, Pacific Maritime
14 Region, for the Masters, Mates, and Pilots Unit;

15 (8) Marine Engineers Beneficial Association, representing licensed engineers
16 employed by the Alaska marine highway system;

17 (9) Public Employees Local 71, for the Labor, Trades and Crafts Unit;

18 (10) Public Safety Employees Association, for the Correctional Officers Unit;

19 (11) Public Safety Employees Association, representing state troopers and other
20 commissioned law enforcement personnel; and

21 (12) Teachers' Education Association of Mt. Edgecumbe.

22 (b) Salary and Benefit Adjustments. The sum of \$2,611,600 is appropriated from the
23 funding sources listed in (d) of this section to the Office of the Governor, office of
24 management and budget, for salary and benefit adjustments for public officials, officers, and
25 employees of the executive branch who are not members of a collective bargaining unit for
26 the fiscal year ending June 30, 2001.

27 (c) Legislative Intent. It is the intent of the legislature that part of the appropriation
28 made in (b) of this section is to provide lump sum payments of \$1,200, reduced by \$50 for
29 each pay period that the officer or employee was not in pay status in fiscal year 2000 and
30 reduced by amounts necessary to pay mandatory employee and employer deductions, for

31 (1) classified and partially exempt officers and employees in the executive

1 branch of the state government who are not members of a collective bargaining unit
 2 established under the authority of AS 23.40.070 - 23.40.260 (Public Employment Relations
 3 Act), employed and in pay status on July 1, 2000; and

4 (2) public officials, officers, and permanent and temporary employees in the
 5 executive branch of the state government who are in the exempt service under AS 39.25, not
 6 members of a collective bargaining unit established under AS 23.40.070 - 23.40.260 (Public
 7 Employment Relations Act), and employed and in pay status on July 1, 2000.

8 (d) Funding Sources and Transfers. (1) The appropriations made in (a) and (b) of
 9 this section are from the following fund sources:

4 (2) The sum of \$980,200 is appropriated from the general fund to the Alaska
5 marine highway system fund (AS 19.65.060(a)) to transfer a sufficient balance to finance
6 appropriations made in (a) and (b) of this section for employees of the Alaska marine highway
7 system.

8 (e) Effects of Nonratification. If a collective bargaining agreement listed in (a) of this
9 section is not ratified by the membership of the respective collective bargaining unit, the
10 appropriations made by this section that are applicable to that collective bargaining unit's
11 agreement are reduced proportionately by the amount for that collective bargaining agreement
12 and the corresponding funding source amounts listed in this section are reduced accordingly.

13 * **Sec. 2. ALASKA COURT SYSTEM.** (a) Salary and Benefit Adjustments. The sum
14 of \$1,154,500 is appropriated from the general fund to the Alaska Court System for salary and
15 benefit adjustments for Alaska Court System employees for the fiscal year ending June 30,
16 2001.

17 (b) Legislative Intent. It is the intent of the legislature that part of the appropriation
18 made in (a) of this section is to provide lump sum payments of \$1,200, reduced by \$50 for
19 each pay period that the employee was not in pay status in fiscal year 2000 and reduced by
20 amounts necessary to pay mandatory employee and employer deductions, for

21 (1) justices of the state supreme court, judges of the state court of appeals,
22 state superior court judges, state district court judges, and state magistrates, employed and in
23 pay status on July 1, 2000; and

24 (2) permanent and temporary employees in the judicial branch of the state
25 government, other than magistrates and judicial officers, who are not members of a collective
26 bargaining unit established under AS 23.40.070 - 23.40.260 (Public Employment Relations
27 Act), and are employed and in pay status on July 1, 2000.

28 * **Sec. 3. UNIVERSITY OF ALASKA.** (a) Salary and Benefit Adjustments; Collective
29 Bargaining Agreements. The sum of \$6,426,300 is appropriated from the funding sources
30 listed in (b) of this section to the University of Alaska for the fiscal year ending June 30,
31 2001, for salary and benefit adjustments for university employees who are not members of a

1 collective bargaining unit and to implement the monetary terms of the collective bargaining
2 agreements of the

3 (1) University of Alaska Classified Employees Association;

4 (2) Alaska Community Colleges' Federation of Teachers;

5 (3) United Academics; and

6 (4) United Academics - Adjuncts.

7 (b) The fund sources for the appropriation made in (a) of this section are as follows:

12 * **Sec. 4.** LEGISLATURE. (a) Salary and Benefit Adjustments. The sum of \$706,000
13 is appropriated from the general fund to the legislature for salary and benefit adjustments for
14 legislators and employees of the legislature for the fiscal year ending June 30, 2001.

15 (b) Legislative Intent. It is the intent of the legislature that part of the appropriation
16 made in (a) of this section is to provide lump sum payments of \$1,200, reduced by \$50 for
17 each pay period that the legislator or employee was not in pay status in fiscal year 2000 and
18 reduced by amounts necessary to pay mandatory employee and employer deductions, for

19 (1) legislators and employees of the legislature under AS 24.10 and AS 24.20,
20 employed and in pay status on July 1, 2000; and

21 (2) employees of the legislature who would otherwise be entitled to payment
22 under (1) of this subsection but who are not employed or in pay status on July 1, 2000,
23 because their employment was limited to the legislative session.

24 * **Sec. 5.** This Act takes effect July 1, 2000.
