Analysis:

House Bill 418 will change the designation of Pioneers' Homes Receipts under AS 47.55.030 collected by the Pioneers' Homes from Pioneers' Homes Receipts to Receipts Supported Services. The change will allow the portion of the Pioneers' Homes budget that is funded through these receipts to be considered separately from the State's general purpose receipts.

Pioneers' Homes receipts are collected from residents for rent and for charges for certain supplies used by residents. The Pioneers' Homes Advisory Board has recommended that the Pioneers' Homes move to a rental rate schedule that would recover the full cost of care by FY2003. The first rate increase went into effect July 1, 1996; the second on July 1, 1997; the third on July 1, 1998, and the fourth on July 1, 1999. Similar increases will occur annually until the last one on July 1, 2002. Collections are expected to stabilize at approximately \$13.0 million based on current projections of residents' ability to pay.
