A RESOLUTION

1 **Proposing an amendment to the Uniform Rules of the Alaska State Legislature**
2 **relating to standing committees; and providing for an effective date.**

3 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 * **Section 1.** Rule 20, Uniform Rules of the Alaska State Legislature, is amended to read:

5 (a) Each house has the following standing committees with the jurisdiction
6 indicated:

7 Finance (all appropriation, revenue, capital improvement, and bonding
8 measures, the executive budget, and the programs and activities of the Department of
9 Revenue)

10 Health, Education and Social Services (the programs and activities of the
11 Department of Health and Social Services, the Department of Education **and Early**
12 **Development**, and the University of Alaska)

13 Judiciary (the programs and activities of the Alaska Court System, **the**
14 **Department of Corrections**, and the Department of Law, and the legal and
15 substantive review of bills referred to it for that purpose)

16 Labor and Commerce (the programs and activities of the Department of Labor

1 **and Workforce Development** relating to labor-management relations, industrial safety,
2 unemployment compensation, and workers' compensation and the programs and
3 activities of the Department of **Community** [COMMERCE] and Economic
4 Development **that do not primarily relate to local government or to government**
5 **services or functions in the unorganized borough)**

6 Community and Regional Affairs (the programs and activities of the
7 Department of Community and **Economic Development that primarily relate to local**
8 **government and government services or functions in the unorganized borough,**
9 [REGIONAL AFFAIRS] and other matters relating to political subdivisions)

10 Resources (the programs and activities of the Departments of Fish and Game,
11 Natural Resources, and Environmental Conservation)

12 Rules (interpretation of the Uniform Rules, calendar, the internal administration
13 of the house and matters pertaining to the management of the legislature as a whole)

14 State Affairs (programs and activities of the Office of the Governor and the
15 Departments of Administration, Military **and Veterans'** Affairs, and Public Safety, and
16 programs and activities of the Department of Transportation and Public Facilities
17 relating to public facilities)

18 Transportation (programs and activities of the Department of Transportation and
19 Public Facilities relating to transportation and other legislative matters relating to
20 transportation).

21 (b) The **persons who chair the committees** [COMMITTEE CHAIRMEN] are
22 authorized to form such subcommittees as they determine to be necessary.

23 * **Sec. 2.** The amendment proposed by this resolution takes effect immediately.
