A BILL

FOR AN ACT ENTITLED

1 **"An Act making appropriations for the operating and loan program expenses of state**
2 **government, for certain programs, and to capitalize funds; making appropriations**
3 **under art. IX, sec. 17(c), Constitution of the State of Alaska, from the constitutional**
4 **budget reserve fund; and providing for an effective date."**

3 appropriations made to the University of Alaska in sec. 1 of this Act:

4 (1) Alaska Higher Education Crafts and Trades Employees, representing
5 certain employees of the University of Alaska;

6 (2) Alaska Community College Federation of Teachers, representing certain
7 employees of the University of Alaska;

8 (3) United Academics, representing certain employees of the University of
9 Alaska;

10 (4) United Academics-Adjuncts, representing certain employees of the
11 University of Alaska.

12 * **Sec. 27.** NONLAPSE OF APPROPRIATIONS. The appropriations made by secs. 3,
13 5(b), 5(c), 5(d), 6, 8, 10(a), 11, 14, 16, 17, 21(c), 21(i), 21(j), 24, and 25 of this Act are for the
14 capitalization of funds and do not lapse.
