A BILL

FOR AN ACT ENTITLED

1 **"An Act relating to concealed handgun permittees."**

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 *** Section 1.** AS 18.65.748 is amended to read:

4 **Sec. 18.65.748. Permit holders from other jurisdictions considered Alaska**
5 **permit holders.** A person holding a valid permit to carry a concealed handgun from
6 another state or a political subdivision of another state

7 [(1) WITH PERMIT REQUIREMENTS SIMILAR TO THOSE IN
8 AS 18.65.700 - 18.65.790] is a permittee under AS 18.65.700(b) for purposes of
9 AS 18.65.750 - 18.65.765 [IF THE PERSON HAS NOT BEEN IN ALASKA FOR
10 MORE THAN 120 CONSECUTIVE DAYS; IN THIS PARAGRAPH, "PERMIT
11 REQUIREMENTS SIMILAR TO THOSE IN AS 18.65.700 - 18.65.790" MEANS
12 THAT, IN ORDER TO RECEIVE AND HOLD THE PERMIT IN THE OTHER
13 STATE OR POLITICAL SUBDIVISION, THE PERSON MUST

14 (A) BE AT LEAST 21 YEARS OF AGE;

15 (B) BE ELIGIBLE TO OWN OR POSSESS A HANDGUN

1 UNDER STATE OR FEDERAL LAW;

2 (C) SUCCESSFULLY COMPLETE SOME TYPE OF
3 HANDGUN OR FIREARMS SAFETY COURSE; AND

4 (D) BE SUBJECT TO A FINGERPRINT-BASED CRIMINAL
5 RECORDS SEARCH;

6 (2) IS A PERMITTEE UNDER AS 18.65.700(b) FOR PURPOSES
7 OF AS 18.65.750 - 18.65.765 IF THE PERSON HAS NOT BEEN IN ALASKA FOR
8 MORE THAN 120 CONSECUTIVE DAYS AND THE OTHER STATE OR
9 POLITICAL SUBDIVISION ALLOWS A PERMITTEE UNDER AS 18.65.700 -
10 18.65.790 TO CARRY A CONCEALED HANDGUN IN THE OTHER STATE OR
11 POLITICAL SUBDIVISION; THE DEPARTMENT SHALL DETERMINE WHICH
12 STATES OR POLITICAL SUBDIVISIONS GRANT RECIPROCITY TO
13 PERMITTEES UNDER AS 18.65.700 - 18.65.790 AND SHALL DISTRIBUTE A
14 LIST OF THOSE JURISDICTIONS TO EACH LAW ENFORCEMENT AGENCY
15 IN THIS STATE].
