A RESOLUTION

1 **Proposing amendments to Uniform Rule 20 of the Alaska State Legislature; and**
2 **providing for an effective date for the amendments.**

3 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 * **Section 1.** Rule 20(a), Uniform Rules of the Alaska State Legislature, is amended to read:

5 (a) Each house has the following standing committees with the jurisdiction
6 indicated:

7 Finance (all appropriation, revenue, capital improvement, and bonding
8 measures, the executive budget, and the programs and activities of the Department of
9 Revenue)

10 [HEALTH, EDUCATION AND SOCIAL SERVICES (THE PROGRAMS
11 AND ACTIVITIES OF THE DEPARTMENT OF HEALTH AND SOCIAL
12 SERVICES, THE DEPARTMENT OF EDUCATION AND EARLY
13 DEVELOPMENT, AND THE UNIVERSITY OF ALASKA)]

14 Judiciary (the programs and activities of the Alaska Court System and the
15 Department of Law, and the legal and substantive review of bills referred to it for that
16 purpose)

1 Labor and Commerce (the programs and activities of the Department of Labor
2 and Workforce Development relating to labor-management relations, industrial safety,
3 unemployment compensation, and workers' compensation and the programs and
4 activities of the Department of Community and Economic Development that do not
5 primarily relate to local government or to government services or functions in the
6 unorganized borough)

7 Community and Regional Affairs (the programs and activities of the
8 Department of Community and Economic Development that primarily relate to local
9 government and government services or functions in the unorganized borough, and
10 other matters relating to political subdivisions)

11 Resources (the programs and activities of the Departments of Fish and Game,
12 Natural Resources, and Environmental Conservation)

13 Rules (interpretation of the Uniform Rules, calendar, the internal
14 administration of the house and matters pertaining to the management of the
15 legislature as a whole)

16 State Affairs (programs and activities of the Office of the Governor and the
17 Departments of Administration, Military and Veterans' Affairs, Corrections, and
18 Public Safety, and programs and activities of the Department of Transportation and
19 Public Facilities relating to public facilities)

20 Transportation (programs and activities of the Department of Transportation
21 and Public Facilities relating to transportation and other legislative matters relating to
22 transportation).

23 * **Sec. 2.** Rule 20, Uniform Rules of the Alaska State Legislature, is amended by adding
24 new subsections to read:

25 (c) In addition to the committees listed in (a) of this section, the senate has the
26 following standing committee with the jurisdiction indicated:

27 Health, Education and Social Services (the programs and activities of the
28 Department of Health and Social Services, the Department of Education and Early
29 Development, and the University of Alaska).

30 (d) In addition to the committees listed in (a) of this section, the house has the
31 following standing committees:

1 Health and Social Services (the programs and activities of the Department of
2 Health and Social Services)

3 Education (the programs and activities of the Department of Education and
4 Early Development and the University of Alaska).

5 * **Sec. 3.** The amendments proposed by this resolution take effect on the day the Twenty-
6 Third Alaska State Legislature convenes in First Regular Session.
