Pursuant to adjournment the House was called to order by Speaker Porter at 10:12 a.m.

Roll call showed 31 members present. Representatives Berkowitz, Bunde, Croft, Davies, Guess, Masek, Mulder, Rokeberg, and Williams were absent and their presence was noted later.
