## **Eighty-eighth Day**

Pursuant to adjournment the House was called to order by Speaker Porter at 10:25 a.m.

Roll call showed 24 members present. Representatives Fate, Foster, Green, and Ogan had been previously excused from a call of the House today. Representatives Berkowitz, Cissna, Crawford, Croft, Davies, Guess, Hayes, Joule, Kapsner, Kerttula, Kookesh, and Moses were absent and their presence was noted later.
