Pursuant to adjournment the House was called to order by Speaker Porter at 10:06 a.m.

Roll call showed 30 members present. Representative Ogan had been previously excused from a call of the House today. Representatives Berkowitz, Croft, Halcro, Kookesh, Kott, Masek, Mulder, and Williams were absent and their presence was noted later.
