Pursuant to adjournment the House was called to order by Speaker Porter at 4:43 p.m.

Roll call showed 34 members present. Representatives James, Moses, and Williams had been previously excused from a call of the House today. Representative Ogan was excused from a call of the House today because of illness. Representatives Croft and Joule were absent.

The invocation was offered by Representative Green, Chaplain Designee. Representative Hudson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
