LEARNING OPPORTUNITY GRANTS WILL PROVIDE THE OPPORTUNITY TO MOVE SCHOOLS TOWARD STANDARDS-BASED EDUCATION, INCLUDING VOCATIONAL EDUCATION PROGRAMS. THE INCREASED FUNDING IS AVAILABLE TO PAY FOR COSTS ASSOCIATED WITH IMPROVING STUDENT PERFORMANCE BY DEVELOPING STANDARDS-BASED PROGRAMS, INCLUDING IMPLEMENTATION OF STANDARDS, ALIGNING STUDENT ASSESSMENT TO STANDARDS, ADOPTING INSTRUCTIONAL MODELS BASED ON BASIC SKILLS, PERFORMANCE TASKS, AND PROJECTS, AND ADOPTING A STANDARDS-BASED REPORTING SYSTEM. Learning opportunity grants will provide the opportunity to move schools toward standards-based education, including vocational education programs. The increased funding is available to pay for costs associated with improving student performance by developing standards-based programs, including implementation of standards, aligning student assessment to standards, adopting instructional models based on basic skills, performance tasks, and projects, and adopting a standards-based reporting system.

(d) The sum of \$35,692,000 is appropriated from the budget reserve fund (art. IX, sec. 17, Constitution of the State of Alaska) to the Department of Education and Early Development for the fiscal year ending June 30, 2003, for payment as learning opportunity grants to school districts based on the school district's average daily membership to pay for instructional programs intended to improve student performance. Learning opportunity grants will provide the opportunity to move schools toward standards-based education, including vocational education programs. The increased funding is available to pay for costs associated with improving student performance by developing standards-based programs, including implementation of standards, aligning student assessment to standards, adopting instructional models based on basic skills, performance tasks, and projects, and adopting a standards-based reporting system.
