SENATOR TERRIAULT called the Senate Committee meeting to order at 3:30 p.m. and said that the discussion was around whether or not to add on page 9 to Section 8 (5) as follows:

(G) incidental use of governmental resources by a legislator or legislative employee to support or oppose a proposed amendment to the state or federal constitution; a legislator or legislative employee may support or oppose a proposed constitutional amendment; however, a legislator or legislative employee may not use governmental resources to solicit or receive contributions for a proposed constitutional amendment.

SENATOR COWDERY moved, contingent on the committee getting limited powers, to delete Section 8 (5)(G) [and to forward the conference report to both bodies]. The committee voted unanimously to approve the motion.

SENATOR TERRIAULT adjourned the meeting at 3:40 p.m.
