A BILL

FOR AN ACT ENTITLED

1 **"An Act increasing certain motor vehicle registration fees."**

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 * **Section 1.** AS 28.10.421(b) is amended to read:

4 (b) The biennial registration fees under this subsection are imposed within the
5 following classifications for:

6 (1) a passenger vehicle or motor home not used or maintained for the
7 transportation of persons or property for hire or for other commercial
8 use..... **\$100** [\$68];

9 (2) a pick-up truck or a van not exceeding 10,000 pounds unladen
10 weight and not registered in the name of a company or business **\$100** [\$78];

11 (3) a taxicab **\$160** [\$138];

12 (4) a motor bus with a seating capacity for 20 or more persons and
13 used exclusively for commercial purposes in the transporting of visitors or tourists
14 **\$300** [\$168];

15 (5) a motorcycle or a motor-driven cycle **\$60** [\$38];

1 (6) a trailer not used or maintained for the transportation of persons or
2 property for hire or for other commercial use, including, but not limited to, a boat
3 trailer, baggage trailer, box trailer, utility trailer, house trailer, travel trailer, or a trailer
4 rented or offered for rent **\$30** [\$10].

5 * **Sec. 2.** AS 28.10.421(c) is amended to read:

6 (c) The biennial registration fees under this subsection are imposed and are
7 based upon the actual unladen weight as established by the manufacturer's advertised
8 weight or upon the actual weight, which the owner shall furnish, subject to the
9 approval of the commissioner or the commissioner's representative, for a vehicle,
10 including a motor vehicle pulling a trailer or semi-trailer, that is registered in the name
11 of a company or business, or is used or maintained for the transportation of passengers
12 for hire, excepting taxicabs and buses under (b) of this section, or for the
13 transportation of property for hire or for other commercial purposes, including a truck,
14 wrecker, tow car, hearse, ambulance, and tractor, as follows:

- 15 (1) up to and including 5,000 pounds **\$180** [\$158];
- 16 (2) more than 5,000 pounds to and including 12,000
17 pounds **\$268** [\$246];
- 18 (3) more than 12,000 pounds to and including 18,000
19 pounds **\$516** [\$494];
- 20 (4) more than 18,000 pounds **\$662** [\$640].

21 * **Sec. 3.** AS 28.10.421(h) is amended to read:

22 (h) The annual registration fees under this subsection for vehicles used for
23 commercial purposes are imposed and are based upon the actual unladen weight as
24 established by the manufacturer's advertised weight or upon the actual weight, which
25 the owner shall furnish, subject to the approval of the commissioner or the
26 commissioner's representative, as follows:

- 27 (1) up to and including 5,000 pounds **\$90** [\$80];
- 28 (2) more than 5,000 pounds to and including 12,000
29 pounds **\$134** [\$124];
- 30 (3) more than 12,000 pounds to and including 18,000
31 pounds **\$258** [\$248];

1 (4) more than 18,000 pounds **\$331** [\$321].

2 * **Sec. 4.** AS 28.10.421(i) is amended to read:

3 (i) A one-time registration fee of **\$20** [\$10] is imposed upon initial registration
4 for a trailer or semi-trailer used for commercial purposes.

5 * **Sec. 5.** AS 28.10.441 is amended to read:

6 **Sec. 28.10.441. Schedule of other fees and charges.** The following fees and
7 charges are imposed by the department for the stated services **that** [WHICH] it
8 provides:

9 (1) title fee, including transfer of title **\$15** [\$5];

10 (2) lien filing fee **\$15** [\$5];

11 (3) replacement of any registration plate set, including special request
12 plates \$5;

13 (4) duplicate of original certificate of title **\$15** [\$5];

14 (5) duplicate of certificate of registration \$2;

15 (6) temporary preregistration permit issued under
16 AS 28.10.031 none;

17 (7) special transport permit issued under AS 28.10.151 \$5;

18 (8) special permit for vehicle used for transport of a person with a
19 disability issued under AS 28.10.495 none.
