creating crimes relating to gambling and setting requirements for gambling; creating the state gaming fund in the general fund; setting a gross receipts tax on gambling games; limiting the authority of a municipality to tax the adjusted gross receipts of gambling games"

Representative Stoltze moved and asked unanimous consent that Amendment No. 1 be adopted.

Objection was heard.

Amendment to Amendment No. 1 was offered by Representative Stoltze:

Delete "each municipality"
Insert "certain municipalities"

Representative Stoltze moved and asked unanimous consent that Amendment to Amendment No. 1 be adopted. There being no objection, it was so ordered.

There being no further objection, Amendment No. 1 as amended (title amendment) was adopted and the new title follows:
