Letter of Intent

It is the intent of the Legislature that the Commissioner of the Department of Health and Social Services convene a task force to review existing Certificate of Need procedures and standards. The task force shall identify measures to improve the efficiency and effectiveness of the Certificate of Need Program. The task force shall include members who represent a broad range of health care facilities, providers, and representatives with a background in health care policy development. The task force will report its findings and recommendations directly to the Commissioner.
