#### **Executive Proclamation**

Under the authority of art. II, sec. 9, and art. III, sec. 17, of the Alaska Constitution, and in the public interest, I am supplementing my proclamation of June 4, 2004, calling the Twenty-Third Legislature of the State of Alaska into its first special session at Juneau, Alaska, on June 22, 2004, with the addition of the following subjects:

- 1. Appropriations to implement the subjects set out in my proclamation dated June 4, 2004; and
- 2. An appropriation to the Department of Commerce, Community and Economic Development to purchase fuel for rural communities for the fiscal year ending June 30, 2005.

This proclamation supplements my proclamation of June 4, 2004.
