FOR AN ACT ENTITLED

1 **"An Act relating to the authority to take oaths, affirmations, and acknowledgments in**
2 **the state, to notarizations, to verifications, to acknowledgments, to fees for issuing**
3 **certificates with the seal of the state affixed, and to notaries public; and providing for an**
4 **effective date."**

5 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

6 * **Section 1.** AS 09.63.010 is amended to read:

7 **Sec. 09.63.010. Oath, affirmation, and acknowledgment.** The following
8 persons may take an oath, affirmation, or acknowledgment in the state:

9 (1) a justice, judge, or magistrate of a court of the State of Alaska or of
10 the United States;

11 (2) a clerk or deputy clerk of a court of the State of Alaska or of the
12 United States;

13 (3) a notary public;

14 (4) a United States postmaster;

1 (5) a commissioned officer under AS 09.63.050(4); [OR]

2 (6) a municipal clerk carrying out the clerk's duties under
3 AS 29.20.380;

4 **(7) the lieutenant governor when carrying out the lieutenant**
5 **governor's duties under AS 24.05.160;**

6 **(8) the presiding officer of each legislative house when carrying**
7 **out the officer's duties under AS 24.05.170.**

18 **certificate** [\$2 FOR THE FIRST THREE FOLIOS OR LESS AND 20 CENTS PER
19 FOLIO FOR EACH ADDITIONAL FOLIO. THE LIEUTENANT GOVERNOR
20 SHALL ACCOUNT FOR THE FEES RECEIVED UNDER THIS SECTION AND

24 governor may commission for the state

25 (1) notaries public without limitation, who are authorized to use the
26 notary seal for all legal purposes; and

27 (2) limited governmental notaries public, who are state, municipal, or
28 federal employees authorized to use the notary seal only for official government
29 business.

30 (b) The term of a notary public commission is four years, except that the term
31 of a limited governmental notary public commission coincides with the term of

1 government employment.

2 (c) A person who is a state, municipal, or federal employee commissioned as a
3 limited governmental notary public may also be commissioned as a notary public
4 without limitation.

5 * **Sec. 8.** AS 44.50.020 is repealed and reenacted to read:

6 **Sec. 44.50.020. Qualifications.** To be commissioned as a notary public, a
7 person

8 (1) shall submit an application under AS 44.50.032;

9 (2) shall be at least 18 years of age;

10 (3) shall have established residency in this state under AS 01.10.055;

11 (4) shall reside legally in the United States;

12 (5) may not, within 10 years before the commission takes effect, have
13 been convicted of a felony or incarcerated in a correctional facility for a felony
14 conviction;

15 (6) may not, within 10 years before the commission takes effect,

16 (A) have had the person's notary public commission revoked
17 under AS 44.50.068(a)(2) or (3) or under the notary public laws of another
18 jurisdiction; or

19 (B) have been disciplined under AS 44.50.068 or under the
20 notary public laws of another state if, at the time the person applies for a notary
21 public commission under this chapter, the disciplinary action prohibits the
22 person from holding a notary public commission; and

23 (7) shall meet the other requirements in this chapter to be

26 **Sec. 44.50.032. Application.** (a) A person applying for a commission as a
27 notary public shall submit a completed application as required by this section, using
28 the forms or format required by the lieutenant governor.

29 (b) A completed application for a commission under AS 44.50.010(a)(1) must
30 include

31 (1) an affirmation that the applicant meets the qualifications set out in

1 AS 44.50.020(2) - (6);

2 (2) the applicant's mailing and physical addresses; the applicant's
3 telephone number, if any; the applicant's employer or business; the physical address
4 and telephone number of the applicant's employer or business at the location where the
5 applicant works; and an electronic mailing address, if any, where the applicant can be
6 contacted;

7 (3) information concerning any denial, suspension, revocation, or
8 restriction of the applicant's commission as a notary public in this state or another
9 jurisdiction; that information must include

10 (A) identification of the jurisdiction;

11 (B) the date the jurisdiction issued the denial, suspension,
12 revocation, or restriction;

13 (C) the reasons for the denial, suspension, revocation, or
14 restriction; and

15 (D) information concerning final resolution of the matter;

16 (4) the applicant's notarized signature on the portion of the application
17 that contains the oath or affirmation required by AS 44.50.035;

18 (5) the fee required by AS 44.50.033; and

19 (6) the bond required by AS 44.50.034.

20 (c) A completed application for a commission under AS 44.50.010(a)(2) must
21 include

22 (1) a signed statement by the applicant's government employer that the
23 commission is needed for the purpose of conducting official government business;

24 (2) the applicant's mailing and physical addresses; the applicant's
25 telephone number, if any; the applicant's employer; the name, address, and telephone
26 number for the employer where the applicant works; and an electronic mailing
27 address, if any, where the applicant can be contacted;

28 (3) the affirmation, information, and signature required by (b)(1), (3),
29 and (4) of this section; and

30 (4) the fee required by AS 44.50.033.

31 **Sec. 44.50.033. Application fee.** A person applying for a commission as a

1 notary public shall pay a nonrefundable application fee of \$40. However, an applicant
 2 for a limited governmental notary public commission under AS 44.50.010(a)(2) who is
 3 employed by the state may not be required to pay an application fee.

4 **Sec. 44.50.034. Bond.** (a) A person applying for a commission as a notary
 5 public without limitation under AS 44.50.010(a)(1) shall execute an official bond of
 6 \$1,000 and submit the bond with the application under AS 44.50.032. The bond must
 7 be for a term of four years from the date of commission.

8 (b) The lieutenant governor shall keep a bond submitted under this section for
 9 two years after the end of the term of the commission for which the bond was issued.
 10 Disposition of the bond after the end of the commission does not affect the time for
 11 commencing an action on the bond.

12 **Sec. 44.50.035. Oath.** The application required by the lieutenant governor
 13 under AS 44.50.032 must contain an oath or affirmation, in the form set out in
 14 AS 39.05.045, to be signed by the applicant. A signed oath or affirmation submitted
 15 in an application under AS 44.50.032 takes effect on the date of the applicant's
 16 commission as a notary public under this chapter.

17 **Sec. 44.50.036. Denial of applications.** The lieutenant governor shall deny
 18 an application for a notary public commission if the

19 (1) applicant does not meet the requirements of this chapter;

20 (2) application is not complete or contains a material misstatement or
 21 omission of fact relating to the requirements for a commission under this chapter;

22 (3) applicant has, within 10 years before the commission is to take
 23 effect, been convicted of a felony or incarcerated in a correctional facility for a felony
 24 conviction; or

25 (4) applicant's commission as a notary public has been revoked, within
 26 10 years before the commission is to take effect, in this state for a reason set out in
 27 AS 44.50.068, or in another jurisdiction for a substantially similar reason.

28 **Sec. 44.50.037. Certificate of commission.** Upon commission of a notary
 29 public under this chapter, the lieutenant governor shall provide to the notary public a
 30 certificate of commission indicating the commission and the dates of the term of the
 31 commission.

1 **Sec. 44.50.038. Subsequent commissions.** A notary public whose term of
 2 commission is ending may apply for a new notary public commission by submitting a
 3 new application under AS 44.50.032 and complying with the requirements of this
 4 chapter. The lieutenant governor's approval of a new application for a commission for
 5 a notary public without limitation under AS 44.50.010(a)(1) terminates an applicant's
 6 existing commission under that paragraph.

7 **Sec. 44.50.039. Limited governmental notaries public.** A state, municipal,
 8 or federal employee commissioned as a notary public under AS 44.50.010(a)(2)

9 (1) is designated a limited governmental notary public;

10 (2) may perform notarial acts only in the conduct of official
 11 government business; and

12 (3) may not charge or receive a fee or other consideration for notarial
 13 services provided under this chapter.

14 * **Sec. 10.** AS 44.50.060 is amended to read:

15 **Sec. 44.50.060. Duties.** A notary public may [SHALL]

16 (1) administer oaths and affirmations [WHEN REQUESTED,
 17 DEMAND ACCEPTANCE AND PAYMENT OF FOREIGN AND INLAND BILLS
 18 OF EXCHANGE, OR PROMISSORY NOTES, PROTEST THEM FOR
 19 NONACCEPTANCE AND NONPAYMENT, AND EXERCISE THE OTHER
 20 POWERS AND DUTIES THAT BY THE LAW OF NATIONS AND ACCORDING
 21 TO COMMERCIAL USAGES, OR BY THE LAWS OF ANY OTHER STATE,
 22 GOVERNMENT, OR COUNTRY, MAY BE PERFORMED BY NOTARIES];

23 (2) take the acknowledgment of or proof of execution of [POWERS
 24 OF ATTORNEY, MORTGAGES, DEEDS, GRANTS, TRANSFERS, AND OTHER]

 26 acknowledgment, included in [ENDORSED ON] or attached to the instrument; the
 27 notarial certificate shall be signed by the notary public in the notary public's

7 **Sec. 44.50.061. Unauthorized practice.** (a) A notary public who is not an
 8 attorney may complete but may not select notarial certificates, and may not assist
 9 another person in drafting, completing, selecting, or understanding a document or
 10 transaction requiring a notarial act.

11 (b) This section does not prohibit a notary public who is qualified in and, if
 12 required, licensed to practice, a particular profession from giving advice relating to
 13 matters in that professional field.

14 (c) A notary public may not make representations to have powers,
 15 qualifications, rights, or privileges that the office of notary public does not have.

16 **Sec. 44.50.062. Prohibited acts.** A notary public may not

17 (1) violate state or federal law in the performance of acts authorized by
 18 this chapter;

19 (2) influence a person to enter into or avoid a transaction involving a
 20 notarial act by the notary public;

21 (3) affix the notary public's signature or seal on a notarial certificate
 22 that is incomplete;

23 (4) charge a fee for a notarial act unless a fee schedule has been
 24 provided to the signer before the performance of the notarial act;

25 (5) affix the notary public's official seal to a document unless the
 26 person who is to sign the document

27 (A) appears and signs the document before the notary public or,
 28 for an acknowledgment, appears and indicates to the notary public that the
 29 person voluntarily affixed the person's signature on the document for the
 30 purposes stated within the document;

31 (B) gives an oath or affirmation if required under law or if the

1 notarial certificate states that the document was signed under oath or
2 affirmation; and

3 (C) is personally known to the notary public, produces
4 government-issued identification containing the photograph and signature of
5 the person signing, or produces

6 (i) government-issued identification containing the
7 signature of the person signing, but without a photograph; and

8 (ii) another valid identification containing the
9 photograph and signature of the person signing;

10 (6) perform a notarial act if the notary public

11 (A) is a signer of or named in the document that is to be
12 notarized; or

13 (B) will receive directly from a transaction connected with the
14 notarial act a commission, fee, advantage, right, title, interest, cash, property,
15 or other consideration exceeding in value the normal fee charged by the notary
16 for the notarial act.

17 **Sec. 44.50.063. Official signature.** (a) When performing a notarization, a
18 notary public shall

19 (1) sign in the notary public's own handwriting, on the notarial
20 certificate, exactly and only the name indicated on the notary public's commission
21 certificate, or sign an electronic document by electronic means as authorized by
22 regulations adopted by the lieutenant governor; and

23 (2) affix the official signature only at the time the notarial act is
24 performed.

25 (b) A notary public shall comply in a timely manner with a request by the
26 lieutenant governor to supply a current sample of the notary public's official
27 handwritten signature and information regarding the notary public's electronic
28 signature.

29 (c) Within 10 days after the security of a notary public's electronic signature
30 has been compromised, the notary public shall provide the lieutenant governor with
31 written notification that the signature has been compromised. After the notary public

1 has provided the lieutenant governor with the notification, the notary public shall
 2 provide the lieutenant governor with any additional information that the lieutenant
 3 governor requests about the compromise of the signature.

4 **Sec. 44.50.064. Official seal.** (a) A notary public shall keep an official seal,
 5 which is the exclusive property of the notary public, and shall ensure that another
 6 person does not possess or use the official seal.

7 (b) A notary public's official seal

8 (1) must contain

9 (A) the notary public's name exactly as indicated on the notary
 10 public's commission certificate;

11 (B) the words "Notary Public" and "State of Alaska"; and

12 (2) may be a circular form not over two inches in diameter, may be a
 13 rectangular form not more than one inch in width by two and one-half inches in
 14 length, or may be an electronic form as authorized by regulations adopted by the
 15 lieutenant governor.

16 (c) When not in use, a notary public's official seal shall be kept secure and
 17 under the exclusive control of the notary public.

18 (d) Within 10 days after a notary public's official seal is stolen or lost, or the
 19 security of the notary public's official electronic seal is compromised, the notary
 20 public shall provide the lieutenant governor with written notification of the theft, loss,
 21 or compromised security. After the notary public has provided the lieutenant governor
 22 with the notification, the notary public shall provide the lieutenant governor with any
 23 additional information that the lieutenant governor requests about the compromise of
 24 the seal.

25 (e) In order to avoid misuse, a notary public's official seal shall be destroyed
 26 or defaced

27 (1) upon the notary public's resignation or death;

28 (2) upon the revocation or termination by the lieutenant governor of
 29 the notary public's commission; or

30 (3) when the notary public's term of commission ends if the notary
 31 public has not received a new commission under this chapter.

1 **Sec. 44.50.065. Seal impression or depiction.** (a) With regard to each paper
2 document being notarized, a sharp, legible, photographically reproducible impression
3 or depiction of a notary public's official seal shall be affixed

4 (1) on the notarial certificate near the notary public's official signature;
5 and

6 (2) only at the time the notarial act is performed.

7 (b) For a notarized paper document, illegible information within a seal
8 impression or depiction may be typed or printed legibly by the notary public adjacent
9 to, but not within, the impression or depiction.

10 (c) An embossed seal impression that is not photographically reproducible
11 may be used in addition to, but not in place of, the seal impression or depiction
12 required by (a) of this section.

13 (d) A notary public may use a seal in electronic form on electronic documents
14 notarized by the notary public as authorized by regulations adopted by the lieutenant
15 governor. The seal shall be affixed only at the time the notarial act is performed.

16 **Sec. 44.50.066. Notary public's status notification.** (a) Within 30 days after
17 change of a notary public's name, mailing address, or physical address, the notary
18 public shall, on a form provided by the lieutenant governor, submit written notification
19 of the change, signed by the notary public.

20 (b) The lieutenant governor may require limited governmental notaries public
21 commissioned under AS 44.50.010(a)(2) who change departmental or agency
22 employers to submit written notification of the change on a form provided by the
23 lieutenant governor.

24 (c) A notary public commissioned under AS 44.50.010(a)(1) reporting a name
25 change shall submit to the lieutenant governor payment of the fee under AS 44.19.024
26 for the issuance of a replacement certificate of commission.

27 (d) A notary public reporting a name change under (a) and (c) of this section
28 shall use the person's former name for the performance of notarial acts until the person
29 has

30 (1) provided written notification of the name change to the surety for
31 any bond required under AS 44.50.034;

1 (2) received a replacement certificate of commission reflecting the
2 name change from the lieutenant governor; and

3 (3) obtained a new seal reflecting the name change.

4 (e) The lieutenant governor may require a notary public to update the
5 information required under AS 44.50.032, including the notary public's current
6 notarized signature and information regarding the notary public's electronic signature.

7 **Sec. 44.50.067. Resignation.** (a) To resign a commission, a notary public
8 shall notify the lieutenant governor in writing of the resignation and the date that it is
9 effective. The notary public shall sign the notification.

10 (b) A notary public who does not any longer meet the requirements of this
11 chapter to be a notary public shall immediately resign the commission.

12 **Sec. 44.50.068. Disciplinary action; complaint; appeal; hearing;**
13 **delegation.** (a) The lieutenant governor may suspend or revoke a notary public's
14 commission or reprimand a notary public for good cause shown, including

15 (1) a ground on which an application for a commission may be denied;

16 (2) failure to comply with this chapter; and

17 (3) incompetence or malfeasance in carrying out the notary public's
18 duties under this chapter.

19 (b) A person harmed by the actions of a notary public may file a complaint
20 with the lieutenant governor. The complaint shall be filed on a form prescribed by the
21 lieutenant governor and shall be signed and verified by the person alleging misconduct
22 by the notary public.

23 (c) If the lieutenant governor determines that the allegations in the complaint
24 do not warrant formal disciplinary action, the lieutenant governor may decline to act
25 on the complaint or may advise the notary public of the appropriate conduct and the
26 applicable statutes and regulations governing the conduct. The lieutenant governor
27 shall notify the notary public and the complainant of the determination in writing.

28 (d) If the lieutenant governor determines that the complaint alleges sufficient
29 facts to constitute good cause for disciplinary action, the lieutenant governor shall
30 serve the notary public with a copy of the complaint as provided in Rule 4, Alaska
31 Rules of Civil Procedure. The notary public may file a written response to the

1 complaint with the lieutenant governor within 20 days after receipt of the complaint.
